Citations Affected: IC 20-12.

Synopsis: Ivy Tech State College board of trustees. Provides that the number of members on the Ivy Tech board of trustees must equal the number of regions into which the board has divided the state. (Current law fixes the number of members at 13.)

Effective: Upon passage.

ENGROSSED HOUSE BILL No. 1330

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 20-12-61-4 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 4. (a) Ivy Tech
3 shall be governed by a board of trustees ~~composed of thirteen (13)~~
4 **members**; appointed by the governor. **The number of members of the**
5 **state board must equal the number of regions established under**
6 **section 9 of this chapter.** Each member of the state board must have
7 knowledge or experience in one (1) or more of the following areas:
8 (1) Manufacturing.
9 (2) Commerce.
10 (3) Labor.
11 (4) Agriculture.
12 (5) State and regional economic development needs.
13 (6) Indiana's educational delivery system.
14 **At least One (1) trustee member of the state board** must reside in
15 each region established under section ~~9(4)~~ **9** of this chapter.
16 Appointments shall be for three (3) year terms, on a staggered basis.
17 (b) No one who holds an elective or appointed office of the state is

1 eligible to serve as a member of the state board. A member of a
2 regional board may be appointed to the state board, but must then
3 resign from the regional board.
