MR. SPEAKER:

I move that House Bill 1180 be amended to read as follows:

- 1 Page 1, delete lines 5 through 6, begin a new paragraph and insert:
- 2 "Sec. 1. An object may be displayed on real property owned by
- 3 the state as provided in this chapter.
- 4 Sec. 2. This chapter does not prohibit the display of an object on
- 5 real property owned by the state if the object is displayed in a
- 6 manner or setting that does not violate federal and Indiana law."
- 7 Page 1, line 7, delete "2." and insert "3. (a)".
- 8 Page 1, line 12, after "Commandments" insert ":
- 9 (1)".
- 10 Page 1, line 13, delete "," and insert ";".
- 11 Page 1, line 14, delete "shall not", begin a new line block indented
- 12 and insert:
- 13 "(2) may not".
- 14 Page 1, between lines 16 and 17, begin a new paragraph and insert:
- 15 "(b) Notwithstanding subsection (a), an object containing the
- 16 words of the Ten Commandments may be displayed on real
- 17 property owned by the state in a manner or setting other than as
- 18 described in subsection (a) if the display satisfies section 2 of this
- 19 chapter."
- 20 Page 2, delete lines 4 through 5, begin a new paragraph and insert:
- 21 "Sec. 1. An object may be displayed on real property owned by
- 22 a political subdivision as provided in this chapter.
- 23 Sec. 2. This chapter does not prohibit the display of an object on
- 24 real property owned by a political subdivision if the object is

- 1 **displayed in a manner or setting that does not violate federal and**
  - 2 **Indiana law."**
  - 3 Page 2, line 6, delete "2." and insert "**3. (a)**".
  - 4 Page 2, line 11, after "Commandments" insert "**:**
  - 5 **(1)**".
  - 6 Page 2, line 13, delete "," and insert ";".
  - 7 Page 2, line 13, delete "shall not", begin a new line block indented
  - 8 and insert:
  - 9 "**(2) may not**".
  - 10 Page 2, after line 15, begin a new paragraph and insert:
  - 11 "**(b) Notwithstanding subsection (a), an object containing the**
  - 12 **words of the Ten Commandments may be displayed on real**
  - 13 **property owned by a political subdivision in a manner or setting**
  - 14 **other than as described in subsection (a) if the display satisfies**
  - 15 **section 2 of this chapter."**
