

SENATE BILL No. 149

DIGEST OF INTRODUCED BILL

Citations Affected: IC 11-10-13.

Synopsis: Indiana learning and family center. Requires the department of correction to establish an Indiana learning and family center. Provides that the center's purpose is to offer family and educational services to criminal offenders and their families and the community in an effort to curtail criminal behavior that is perpetuated by poor education and lack of services and resources. Requires the center to establish numerous programs, including: (1) a community based literacy program; (2) a workplace skills enhancement program; (3) a summer enrichment program; and (4) a youth opportunity task force program. Provides that the center is comprised of both a learning center and a family center. Requires the learning center instructors and the family center advocates to cooperate to assist clients in accessing services most appropriate to their needs and goals. Requires the learning center to offer classes in the following areas: (1) Literacy. (2) Adult basic education. (3) General educational development. Requires the center to collect certain data relating to the center's performance.

A BILL FOR AN ACT to amend the Indiana Code concerning corrections.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 11-10-13 IS ADDED TO THE INDIANA CODE
- 2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
- 3 JULY 1, 2000]:
- 4 **Chapter 13. Indiana Learning and Family Center**
- 5 **Sec. 1. As used in this chapter, "center" refers to the Indiana**
- 6 **learning and family center.**
- 7 **Sec. 2. The department shall implement a plan to establish the**
- 8 **Indiana learning and family center. The department shall select the**
- 9 **site for the center's location.**
- 10 **Sec. 3. The department may adopt rules under IC 4-22-2 to**
- 11 **carry out this chapter.**
- 12 **Sec. 4. The purpose of the center is to provide family and**
- 13 **educational services to:**
- 14 **(1) criminal offenders and their families; and**
- 15 **(2) the community;**
- 16 **in an effort to curtail criminal behavior that is perpetuated by poor**
- 17 **education and lack of services and resources.**



1 **Sec. 5. The center shall do the following:**

2 (1) Provide substance abuse and educational assessments to
3 persons charged with an offense who use the center's services
4 and forward the assessments to the court in an effort to divert
5 appropriate offenders to treatment programs as a condition
6 of probation or parole.

7 (2) Refer families and neighborhoods to the center activities
8 that address their needs.

9 (3) Establish a community based literacy program for:

10 (A) criminal offenders and their families; and

11 (B) the community.

12 **Sec. 6. (a) The center must:**

13 (1) be comprised of both a learning center and a family
14 center; and

15 (2) share a coordinator and administrative support.

16 (b) The learning center instructors and the family center
17 advocates shall work cooperatively to assist clients in accessing
18 services most appropriate to their individual needs and goals.

19 **Sec. 7. (a) The focus of the learning center is on providing**
20 **educational services to the offender population and to the**
21 **community.**

22 (b) The learning center must offer the following classes:

23 (1) Literacy.

24 (2) Adult basic education.

25 (3) Education leading to a general educational development
26 (GED) diploma.

27 (c) The classes must be offered free of charge.

28 **Sec. 8. (a) The center's methods of instruction must differ**
29 **according to a student's skill level as follows:**

30 (1) Individual instruction must be provided for a student who
31 is functioning at the literacy level.

32 (2) Small group and lecture instruction must be provided for
33 students functioning at the adult basic education and the
34 general educational development (GED) diploma level.

35 (3) A customized computer assisted education program must
36 be provided for students at all levels.

37 (b) The instruction must focus on reading, mathematics,
38 language, writing, sciences, and social studies.

39 **Sec. 9. (a) The center must develop a workplace skills**
40 **enhancement program to assist individuals who are in the**
41 **workforce to upgrade skills for more effective job performance.**

42 (b) The classes and individual instruction must link work

1 related lessons with job specific materials and situations, providing
 2 both theoretical and vocational training. Other classes must allow
 3 employed persons to improve basic skills in reading, writing, and
 4 mathematics and prepare for general educational development
 5 (GED) examinations.

6 **Sec. 10. (a) The center must establish a summer enrichment
 7 program.**

8 **(b) The program must offer:**

- 9 (1) youth workplace training;
 10 (2) part-time employment; and
 11 (3) half day educational instruction in reading and
 12 mathematics.

13 **Sec. 11. (a) The center must establish a youth opportunity task
 14 force program.**

15 **(b) The purpose of the program includes the following:**

- 16 (1) Decreasing the crime rate of youthful offenders by
 17 twenty-five percent (25%).
 18 (2) Decreasing gang activity by twenty percent (20%).
 19 (3) Increasing community involvement with youths through
 20 participation in community service projects.

21 **Sec. 12. The program must provide intervention services to first
 22 time juvenile offenders.**

23 **Sec. 13. The center shall collect data on the following:**

- 24 (1) Number of offenders diverted to the program.
 25 (2) Number of citizens in the area using the program's
 26 resources.
 27 (3) Number of referrals made by the center.
 28 (4) Number of placements in service and follow-up programs.
 29 (5) Average increase in the learning center participants'
 30 achievement levels.
 31 (6) Number of participants receiving general educational
 32 development (GED) diplomas or completing educational
 33 programming.
 34 (7) The learning center's effect on illiteracy and the local
 35 crime rate.
 36 (8) The level of community support for the center.
