Citations Affected: IC 25-23.6; noncode.

Synopsis: Social worker licensing. Provides that a person who has a bachelor's degree in social work and meets certain other requirements may be licensed as a bachelor's social worker.

Effective: July 1, 2001.

HOUSE BILL No. 1448

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 25-23.6-1-1.7 IS ADDED TO THE INDIANA
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2001]: **Sec. 1.7. "Bachelor's social worker"**
4 **means an individual who is licensed under IC 25-23.6-5-0.5.**

5 SECTION 2. IC 25-23.6-1-3.8 IS AMENDED TO READ AS
6 FOLLOWS [EFFECTIVE JULY 1, 2001]: Sec. 3.8. Except as provided
7 in IC 25-23.6-7-5, as used in this chapter, "counselor" refers to a
8 **bachelor's social worker**, social worker, clinical social worker,
9 marriage and family therapist, or a mental health counselor who is
10 licensed under this article.

11 SECTION 3. IC 25-23.6-5-0.5 IS ADDED TO THE INDIANA
12 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
13 [EFFECTIVE JULY 1, 2001]: **Sec. 0.5. (a) An individual who applies**
14 **for a license as a bachelor's social worker must meet the following**
15 **requirements:**

(A) has received at least a bachelor's degree in social work from:

(i) an institution of higher education that is accredited or approved for candidacy by the Council on Social Work Education or approved by the board; or

(ii) a foreign school that has a program of study that is approved by the Foreign Equivalency Determination Service of the Council on Social Work Education; and

(B) will, after receiving a bachelor's social worker license under this section, practice social work under the supervision of a licensed social worker, a licensed clinical social worker, or another supervisor, for the equivalent of two (2) years.

(2) Furnish satisfactory evidence to the board that the individual does not have a conviction for a crime that has a direct bearing on the individual's ability to practice competently.

(3) Furnish satisfactory evidence to the board that the individual has not been the subject of a disciplinary action by a licensing or certification agency of another state or jurisdiction on the grounds that the individual was not able to practice as a social worker without endangering the public.

(4) Pass a basic examination required by the board.

(5) Pay the fee established by the board.

(b) The scope of practice of an individual licensed under this section is the same as the scope of practice of an individual licensed under section 1 of this chapter.

SECTION 4. IC 25-23.6-5-4 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2001]: Sec. 4. An individual who satisfies the requirements of:

(1) section 1, 1.5, or 2 of this chapter; and

(2) section 3 of this chapter;

may take the examination provided by the board.

SECTION 5. IC 25-23.6-5-11 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2001]: Sec. 11. (a) The board may issue a temporary permit to an individual to profess to be a **bachelor's social worker**, social worker, or clinical social worker if the individual pays a fee and the individual:

(1) has a valid license or certificate to practice from another state and the individual has passed an examination substantially equivalent to the level for which licensure is being requested;

(2) is practicing in a state that does not license or certify social

- 1 workers or clinical social workers, but is certified by a national
- 2 association approved by the board and the individual has applied
- 3 for a license from the board; or
- 4 (3) has been approved by the board to take the examination and
- 5 has graduated from a school or program approved by the board
- 6 and the individual has completed any experience requirement.
- 7 (b) A temporary permit expires the earlier of:
- 8 (1) the date the individual holding the permit is issued a license
- 9 under this article;
- 10 (2) the date the board disapproves the individual's license
- 11 application; or
- 12 (3) one hundred eighty (180) days after the initial permit is issued.
- 13 (c) The board may renew a temporary permit if the individual
- 14 holding the permit was scheduled to take the next examination and the
- 15 individual:
- 16 (1) did not take the examination; and
- 17 (2) shows good cause for not taking the examination.
- 18 (d) A permit renewed under subsection (c) expires on the date the
- 19 individual holding the permit receives the results from the next
- 20 examination given after the permit was issued, and may not be
- 21 extended if the applicant has failed the examination.

Page 1, line 14, delete "basic" and insert "**bachelor's**".

Page 2, line 9, delete "will work in the practice of" and insert "**will, after receiving a bachelor's social worker license under this section, practice**".

Page 2, line 11, delete "as determined by the" and insert "**for the equivalent of two (2) years.**".

Page 2, delete line 12.

Page 2, line 22, delete "an" and insert "**a basic**".

Page 2, delete lines 24 through 27, begin a new paragraph and insert:

"(b) The scope of practice of an individual licensed under this section is the same as the scope of practice of an individual licensed under section 1 of this chapter".

Page 2, line 36, delete "basic" and insert "**bachelor's**".
