Whereas, The Indiana Football Hall of Fame was started in January 1973 in affiliation with the Indiana Football Coaches Association;

Whereas, The purpose of the Indiana Football Hall of Fame is to establish scholarships and endowments for excellence in football in the state of Indiana;

Whereas, Candidates for induction into the Indiana Football Hall of Fame include coaches, players, officials, members of the sports media, and citizens who have made important contributions in the advancement of football excellence;

Whereas, The Indiana Football Hall of Fame includes exhibits from Indiana's prestigious football history, ranging from the early 1920s to the present and into the future;

Whereas, Former Indiana football greats Marty Amsler, Mike Blake, Ed Wessel, Frank Will, Ralph Weinzapfel, Scott Studwell, Jim Byers, and Mitch Marsch will be inducted into the Indiana Football Hall of Fame on March 3, 2001, in Evansville, Indiana; and
