DIGEST OF INTRODUCED BILL

Synopsis: Filing of insurance fees. Authorizes the insurance commissioner to adopt rules providing for the accrual and quarterly billing of insurance filing fees.

SENATE BILL No. 386



A BILL FOR AN ACT to amend the Indiana Code concerning insurance.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 27-1-3-15, AS AMENDED BY P.L.268-1999,
2 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2001]: Sec. 15. (a) Except as provided in subsection (g), the
4 commissioner shall collect the following filing fees:

1 (b) The commissioner shall collect a fee of ten dollars (\$10) each
2 time process is served on the commissioner under this title.

3 (c) The commissioner shall collect the following fees for copying
4 and certifying the copy of any filed document relating to a domestic or
5 foreign corporation:

6 Per page for copying As determined by
7 the commissioner but not to exceed actual cost

8 For the certificate \$10

9 (d) Each domestic and foreign insurer shall remit annually to the
10 commissioner for deposit into the department of insurance fund
11 established by IC 27-1-3-28 three hundred fifty dollars (\$350) as an
12 internal audit fee. All assessment insurers, farm mutuals, fraternal
13 benefit societies, and health maintenance organizations shall remit to
14 the commissioner for deposit into the department of insurance fund one
15 hundred dollars (\$100) annually as an internal audit fee.

16 (e) Beginning July 1, 1994, each insurer shall remit to the
17 commissioner for deposit into the department of insurance fund
18 established by IC 27-1-3-28 a fee of thirty-five dollars (\$35) for each
19 policy, rider, and endorsement filed with the state. However, each
20 policy, rider, and endorsement filed as part of a particular product
21 filing and associated with that product filing shall be considered to be
22 a single filing and subject only to one (1) thirty-five dollar (\$35) fee.

23 (f) The commissioner shall pay into the state general fund by the
24 end of each calendar month the amounts collected during that month
25 under subsections (a), (b), and (c).

26 (g) The commissioner may not collect fees for quarterly statements
27 filed under IC 27-1-20-33.

28 (h) **The commissioner may adopt rules under IC 4-22-2 to**
29 **provide for the accrual and quarterly billing of fees under this**
30 **section.**
