## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 25-23.6.

**Synopsis:** Social worker licensing. Provides that a person who has a bachelor's degree in social work and meets certain other requirements may be licensed as a basic social worker. Provides that the social worker, marriage and family therapist, and mental health counselor board may limit a basic social worker's practice of social work.

**Effective:** July 1, 2001.

## HOUSE BILL No. 1448



A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 25-23.6-1-1.7 IS ADDED TO THE INDIANA  
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS  
3 [EFFECTIVE JULY 1, 2001]: **Sec. 1.7. "Basic social worker" means**  
4 **an individual who is licensed under IC 25-23.6-5-1.5.**

5 SECTION 2. IC 25-23.6-1-3.8 IS AMENDED TO READ AS  
6 FOLLOWS [EFFECTIVE JULY 1, 2001]: Sec. 3.8. Except as provided  
7 in IC 25-23.6-7-5, as used in this chapter, "counselor" refers to a **basic**  
8 **social worker**, social worker, clinical social worker, marriage and  
9 family therapist, or a mental health counselor who is licensed under  
10 this article.

11 SECTION 3. IC 25-23.6-5-1.5 IS ADDED TO THE INDIANA  
12 CODE AS A **NEW** SECTION TO READ AS FOLLOWS  
13 [EFFECTIVE JULY 1, 2001]: **Sec. 1.5. (a) An individual who applies**  
14 **for a license as a basic social worker must meet the following**  
15 **requirements:**

16 (1) **Furnish satisfactory evidence to the board that the**  
17 **individual:**



1 (A) has received at least a bachelor's degree in social work  
2 from:

3 (i) an institution of higher education that is accredited or  
4 approved for candidacy by the Council on Social Work  
5 Education or approved by the board; or

6 (ii) a foreign school that has a program of study that is  
7 approved by the Foreign Equivalency Determination  
8 Service of the Council on Social Work Education; and

9 (B) will work in the practice of social work under the  
10 supervision of a licensed social worker, a licensed clinical  
11 social worker, or another supervisor, as determined by the  
12 board, after receiving the bachelor's degree.

13 (2) Furnish satisfactory evidence to the board that the  
14 individual does not have a conviction for a crime that has a  
15 direct bearing on the individual's ability to practice  
16 competently.

17 (3) Furnish satisfactory evidence to the board that the  
18 individual has not been the subject of a disciplinary action by  
19 a licensing or certification agency of another state or  
20 jurisdiction on the grounds that the individual was not able to  
21 practice as a social worker without endangering the public.

22 (4) Pass an examination required by the board.

23 (5) Pay the fee established by the board.

24 (b) The board may limit or restrict the practice of social work  
25 that may be performed by an individual who meets the  
26 requirements under subsection (a) and is licensed as a basic social  
27 worker.

28 SECTION 4. IC 25-23.6-5-4 IS AMENDED TO READ AS  
29 FOLLOWS [EFFECTIVE JULY 1, 2001]: Sec. 4. An individual who  
30 satisfies the requirements of:

31 (1) section 1, 1.5, or 2 of this chapter; and

32 (2) section 3 of this chapter;

33 may take the examination provided by the board.

34 SECTION 5. IC 25-23.6-5-11 IS AMENDED TO READ AS  
35 FOLLOWS [EFFECTIVE JULY 1, 2001]: Sec. 11. (a) The board may  
36 issue a temporary permit to an individual to profess to be a **basic social**  
37 **worker**, social worker, or clinical social worker if the individual pays  
38 a fee and the individual:

39 (1) has a valid license or certificate to practice from another state  
40 and the individual has passed an examination substantially  
41 equivalent to the level for which licensure is being requested;

42 (2) is practicing in a state that does not license or certify social

1 workers or clinical social workers, but is certified by a national  
2 association approved by the board and the individual has applied  
3 for a license from the board; or  
4 (3) has been approved by the board to take the examination and  
5 has graduated from a school or program approved by the board  
6 and the individual has completed any experience requirement.  
7 (b) A temporary permit expires the earlier of:  
8 (1) the date the individual holding the permit is issued a license  
9 under this article;  
10 (2) the date the board disapproves the individual's license  
11 application; or  
12 (3) one hundred eighty (180) days after the initial permit is issued.  
13 (c) The board may renew a temporary permit if the individual  
14 holding the permit was scheduled to take the next examination and the  
15 individual:  
16 (1) did not take the examination; and  
17 (2) shows good cause for not taking the examination.  
18 (d) A permit renewed under subsection (c) expires on the date the  
19 individual holding the permit receives the results from the next  
20 examination given after the permit was issued, and may not be  
21 extended if the applicant has failed the examination.
