DIGEST OF INTRODUCED BILL

Citations Affected: IC 35-41-1-17.

Synopsis: Federal enforcement officers. Adds a United States Immigration and Naturalization Service special agent to the definition of "federal enforcement officer" for purposes of Title 35 of the Indiana Code concerning criminal law and procedure and all other statutes relating to penal offenses.

Effective: July 1, 2001.

A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 35-41-1-17 IS AMENDED TO READ AS
- 2 FOLLOWS [EFFECTIVE JULY 1, 2001]: Sec. 17. (a) "Law
- 3 enforcement officer" means:
- 4 (1) a police officer, sheriff, constable, marshal, or prosecuting
- 5 attorney;
- 6 (2) a deputy of any of those persons;
- 7 (3) an investigator for a prosecuting attorney;
- 8 (4) a conservation officer; or
- 9 (5) an enforcement officer of the alcoholic beverage commission.
- 10 (b) "Federal enforcement officer" means any of the following:
- 11 (1) A Federal Bureau of Investigation special agent.
- 12 (2) A United States Marshals Service marshal or deputy.
- 13 (3) A United States Secret Service special agent.
- 14 (4) A United States Fish and Wildlife Service special agent.
- 15 (5) A United States Drug Enforcement Agency agent.
- 16 (6) A Bureau of Alcohol, Tobacco, and Firearms agent.
- 17 (7) A United States Forest Service law enforcement officer.



- 1 (8) A United States Department of Defense police officer or
- 2 criminal investigator.
- 3 (9) A United States Customs Service agent.
- 4 (10) A United States Postal Service investigator.
- 5 (11) A National Park Service law enforcement commissioned
- 6 ranger.
- 7 **(12) A United States Immigration and Naturalization Service**
- 8 **special agent.**
