

HOUSE BILL No. 1688

DIGEST OF INTRODUCED BILL

Citations Affected: IC 14-13-3.

Synopsis: Lake Michigan marina development commission. Adds the following members to the marina commission: (1) A member of the general assembly who resides in Lake County. (2) A member of the general assembly who resides in LaPorte County. (3) A member of the general assembly who resides in Porter County. Provides that the legislative members serve one year terms. Prohibits more than two members from being of the same political party or from the same chamber of the general assembly. Provides that the members are to be appointed by the governor.

Effective: Upon passage; July 1, 2001.

A BILL FOR AN ACT to amend the Indiana Code concerning transportation.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 14-13-3-4 IS AMENDED TO READ AS
- 2 FOLLOWS [EFFECTIVE JULY 1, 2001]: Sec. 4. (a) The commission
- 3 consists of the following members:
- 4 (1) The executive of Gary.
- 5 (2) The executive of Hammond.
- 6 (3) The executive of East Chicago.
- 7 (4) The executive of Portage.
- 8 (5) The executive of Michigan City.
- 9 (6) The executive of Whiting.
- 10 (7) The director of the department of commerce, who is a
- 11 nonvoting member.
- 12 (8) The director of the department, who is a nonvoting member.
- 13 **(9) Three (3) members of the general assembly, who are**
- 14 **nonvoting members appointed under section 5.5 of this**
- 15 **chapter.**
- 16 (b) A member of the commission may designate an individual to
- 17 serve on the commission in the member's place.



1 SECTION 2. IC 14-13-3-5.5 IS ADDED TO THE INDIANA CODE
 2 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
 3 1, 2001]: **Sec. 5.5. (a) The members appointed to the commission
 4 from the general assembly are as follows:**

5 (1) A member who resides in Lake County.

6 (2) A member who resides in LaPorte County.

7 (3) A member who resides in Porter County.

8 (b) Not more than two (2) members appointed under this section
 9 may be of:

10 (1) the same political party; or

11 (2) the same chamber of the general assembly.

12 (c) The governor shall annually make the appointments
 13 required under this section.

14 (d) If a member of the general assembly appointed under this
 15 section ceases to be a member of the general assembly, the member
 16 also ceases to be a member of the commission, creating a vacancy
 17 on the commission.

18 (e) If a vacancy exists under subsection (d), the governor shall
 19 appoint a member of the general assembly to fill the vacancy for
 20 the duration of the former member's term. A member appointed
 21 under this subsection must have the same qualifications as the
 22 former member whose position has become vacant.

23 SECTION 3. IC 14-13-3-6 IS AMENDED TO READ AS
 24 FOLLOWS [EFFECTIVE JULY 1, 2001]: **Sec. 6. (a) Except as
 25 provided in subsection (c), members of the commission are not
 26 entitled to receive from the commission a per diem. However, the
 27 members are entitled to receive an amount for mileage or travel.**

28 (b) Designees:

29 (1) of members of the commission; and

30 (2) who are not holders of public office;

31 are entitled to receive from the commission an amount for per diem,
 32 mileage, and travel allowance equal to that fixed by the budget agency
 33 as payment to all persons entitled to receive those payments from the
 34 state.

35 (c) A member appointed under section 5.5 of this chapter is
 36 entitled to receive the same per diem, mileage, and travel
 37 allowances paid to members of the general assembly serving on
 38 interim study committees established by the legislative council.

39 SECTION 4. [EFFECTIVE UPON PASSAGE] (a) The
 40 appointments made by the governor under IC 14-13-3-5.5, as
 41 added by this act, must be made not later than June 30, 2001.

42 (b) This SECTION expires July 1, 2001.
