

# SENATE MOTION

**MR. PRESIDENT:**

**I move** that Engrossed House Bill 1902 be amended to read as follows:

- 1           Page 1, between the enacting clause and line 1, begin a new  
2 paragraph and insert:  
3           "SECTION 1. IC 4-31-9-5 IS AMENDED TO READ AS  
4 FOLLOWS [EFFECTIVE JULY 1, 2001]: Sec. 5. (a) At the close of  
5 each day on which pari-mutuel wagering is conducted, each permit  
6 holder or satellite facility operator shall pay to the department of state  
7 revenue a tax equal to twenty cents (\$0.20) for each person who paid  
8 an admission charge for the privilege of entering the racetrack grounds  
9 or satellite facility on that day. Separate computations shall be made of  
10 the number of patrons at each location. If tickets are issued for more  
11 than one (1) day, the sum of twenty cents (\$0.20) shall be paid for each  
12 person using the ticket on each day that it is used.  
13           (b) Before the fifteenth day of each month, the taxes collected under  
14 subsection (a) during the preceding month shall be distributed as  
15 follows:  
16           (1) Fifty percent (50%) of the taxes shall be distributed in equal  
17 shares to the fiscal officers of:  
18           (A) the city, if any;  
19           (B) the town, if any; and  
20           (C) the county;  
21           in which the racetrack is located. The city, town, or county may  
22 use this money as general fund operating revenues. **However, the**  
23 **city, town, or county may not use money received under this**  
24 **section from a satellite facility offering pull tabs to reduce the**  
25 **property tax levy of the city, town, or county for a particular**  
26 **year unless the property tax levy reduction is approved by the**  
27 **voters of the city, town, or county in a local public question or**  
28 **by the fiscal body of the city, town, or county in an ordinance.**  
29           (2) Fifty percent (50%) of the taxes shall be deposited in the state  
30 general fund.  
31           (c) The tax imposed by this section is a listed tax for purposes of

1 IC 6-8.1-1."  
2 Page 3, between lines 33 and 34, begin a new line blocked left and  
3 insert:  
4 **"However, The unit may not use money received under subsection**  
5 **(b)(1), (b)(2), or (c)(1) from a riverboat conducting flexible**  
6 **boarding to reduce the property tax levy of the unit for a**  
7 **particular year unless the property tax levy reduction is approved**  
8 **by the voters of the unit in a local public question or by the fiscal**  
9 **body of the unit in an ordinance."**  
10 Renumber all SECTIONS consecutively.
