MR. SPEAKER:

I move that Engrossed Senate Bill 19 be amended to read as follows:

- 1 Page 6, delete lines 9 through 42.
- 2 Delete pages 7 through 15.
- 3 Page 16, delete lines 1 through 19, begin a new paragraph and insert:
- 4 "SECTION 14. IC 6-1.1-11-9 IS AMENDED TO READ AS
- 5 FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 9. (a) Except as
- 6 provided in subsection (b), ~~of this section~~, all property otherwise
- 7 subject to assessment under this article shall be assessed in the usual
- 8 manner, whether or not it is exempt from taxation.
- 9 (b) No assessment shall be made of property which is owned by the
- 10 government of the United States, this state, an agency of this state, or
- 11 a political subdivision of this state if the property is used, and in the
- 12 case of real property occupied, by the owner.
- 13 (c) **Before the date specified in the following table, a township**
- 14 **assessor shall assess the corresponding percentage of exempt**
- 15 **properties in the assessor's township that the assessor is required**
- 16 **to assess under subsection (a):**

<b>January 1, 2003</b>	<b>25%</b>
<b>January 1, 2004</b>	<b>50%</b>
<b>January 1, 2005</b>	<b>75%</b>
<b>January 1, 2006</b>	<b>100%</b>
- 22 (d) **Before February 15 on forms prescribed by the department**
- 23 **of local government finance, each county assessor shall report to**
- 24 **the county treasurer and the department of local government**

- 1 **finance:**
- 2 **(1) the number of parcels of property in the assessor's**
- 3 **township that are:**
- 4 **(A) exempt from property taxation; and**
- 5 **(B) required to be assessed under subsection (a); and**
- 6 **(2) the number of parcels described under subdivision (1) that**
- 7 **have been assessed.**
- 8 **(e) If a township assessor fails to comply with subsection (c), the**
- 9 **county treasurer shall withhold from the annual salary of the**
- 10 **township assessor an amount equal to the number of years that the**
- 11 **township assessor has failed to comply with subsection (c)**
- 12 **multiplied by five hundred dollars (\$500)."**
- 13 **Renumber all SECTIONS consecutively.**
