## HOUSE MOTION \_\_\_\_\_

MR. SPEAKER:

I move that Engrossed Senate Bill 292 be amended to read as follows:

- 1 Page 2, between lines 2 and 3, begin a new paragraph and insert:  
2 "SECTION 2. IC 20-6.1-5-2.5 IS ADDED TO THE INDIANA  
3 CODE AS A NEW SECTION TO READ AS FOLLOWS  
4 [EFFECTIVE JULY 1, 2002]: **Sec. 2.5. (a) For school corporations**  
5 **where teachers' salaries, compensation, and other benefits are**  
6 **determined under a contract reached through collective bargaining**  
7 **under IC 20-7.5, this section applies to teachers' salaries,**  
8 **compensation, and other benefits under collective bargaining**  
9 **contracts that are executed and take effect after June 30, 2002.**  
10 (b) As used in this section, "approved academic credit" refers  
11 to academic credit in courses approved by the board.  
12 (c) For purposes of determining teachers' salaries,  
13 compensation, and other benefits, the following apply:  
14 (1) A school corporation shall count in the number of credit  
15 hours attributable to an individual teacher all hours of  
16 approved academic credit that the teacher earns beyond an  
17 undergraduate degree.  
18 (2) A school corporation may elect to count in the number of  
19 credit hours attributable to an individual teacher any credit  
20 hours that the teacher earns beyond an undergraduate degree  
21 that are not approved academic credit.  
22 (3) A school corporation shall recognize as equivalent:  
23 (A) a teacher who earns a master's degree; and  
24 (B) a teacher who earns an amount of approved academic

- 2                    (i) is determined through collective bargaining under
- 3                    **IC 20-7.5; and**
- 4                    (ii) does not exceed thirty-six (36) hours.
- 5                    **(d) Compensation for continuing education or professional**
- 6                    **development activities that are required in order to obtain or**
- 7                    **retain a teaching license shall be determined in accordance with**
- 8                    **IC 20-7.5. This section does not limit the rights of the school**
- 9                    **employer or the exclusive representative to mutually establish**
- 10                   **under IC 20-7.5 compensation for continuing education or**
- 11                   **professional development activities that are in addition to**
- 12                   **requirements to obtain or retain a teaching license."**
- 13                    Renumber all SECTIONS consecutively.
