## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 9-18-25-7; IC 9-18-25-9.

**Synopsis:** Special group motorcycle license plates. Provides that a special group recognition license plate may be displayed on a motorcycle and that a special group recognition license plate may not be transferred: (1) to a passenger motor vehicle, certain trucks, or a recreational vehicle from a motorcycle; or (2) from those motor vehicles to a motorcycle.

**Effective:** July 1, 2002.

# HOUSE BILL No. 1198



A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 9-18-25-7 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JULY 1, 2002]: Sec. 7. A special group  
3 recognition license plate issued under this chapter may be displayed on  
4 the following:

- 5 (1) A passenger motor vehicle.
- 6 (2) A truck registered as a truck with a declared gross weight of
- 7 not more than eleven thousand (11,000) pounds.
- 8 (3) A recreational vehicle.
- 9 **(4) A motorcycle.**

10 SECTION 2. IC 9-18-25-9 IS AMENDED TO READ AS  
11 FOLLOWS [EFFECTIVE JULY 1, 2002]: Sec. 9. A person who owns  
12 a motor vehicle registered under this chapter may transfer the special  
13 group recognition license plate from the motor vehicle to another motor  
14 vehicle eligible to be registered under this chapter. **However, a person**  
15 **may not transfer a special group recognition license plate from:**

- 16 **(1) a motor vehicle described in section (7)(1), (7)(2), or (7)(3)**
- 17 **of this chapter to a motorcycle; or**



1           **(2) a motorcycle to a motor vehicle described in section (7)(1),**  
2           **(7)(2), or (7)(3) of this chapter.**  
3           **SECTION 3. [EFFECTIVE JULY 1, 2002] (a) Notwithstanding**  
4           **IC 9-18-25-7, as amended by this act:**  
5           **(1) a special group recognition plate for a motorcycle may not**  
6           **be issued to a member of the Indiana Hoosier Veterans under**  
7           **the authority of IC 9-18-25-2(3) before January 1, 2003; and**  
8           **(2) a special group license plate for a motorcycle not described**  
9           **in subdivision (1) may not be issued before January 1, 2004.**  
10          **(b) This SECTION expires January 1, 2004.**
