

# COMMITTEE REPORT

## MR. PRESIDENT:

**The Senate Committee on Corrections, Criminal and Civil Procedures, to which was referred Senate Bill No. 207, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:**

- 1           Page 1, between the enacting clause and line 1, begin a new  
2 paragraph and insert:  
3           "SECTION 1. IC 5-2-5-5, AS AMENDED BY P.L.272-2001,  
4 SECTION 2, AND AS AMENDED BY P.L.228-2001, SECTION 2, IS  
5 AMENDED AND CORRECTED TO READ AS FOLLOWS  
6 [EFFECTIVE JULY 1, 2002]: Sec. 5. (a) Except as provided in  
7 subsection (b), on request, law enforcement agencies shall release or  
8 allow inspection of a limited criminal history to noncriminal justice  
9 organizations or individuals only if the subject of the request:  
10           (1) has applied for employment with a noncriminal justice  
11 organization or individual;  
12           (2) has applied for a license and criminal history data as required  
13 by law to be provided in connection with the license;  
14           (3) is a candidate for public office or a public official;  
15           (4) is in the process of being apprehended by a law enforcement  
16 agency;  
17           (5) is placed under arrest for the alleged commission of a crime;  
18           (6) has charged that his rights have been abused repeatedly by  
19 criminal justice agencies;  
20           (7) is the subject of judicial decision or determination with

- 1 respect to the setting of bond, plea bargaining, sentencing, or  
 2 probation;
- 3 (8) has volunteered services that involve contact with, care of, or  
 4 supervision over a child who is being placed, matched, or  
 5 monitored by a social services agency or a nonprofit corporation;
- 6 **(9) is employed by a public school (as defined in  
 7 IC 20-10.1-1-2) or nonpublic school (as defined in  
 8 IC 20-10.1-1-3) or by an entity that seeks to enter into a  
 9 contract with a public or nonpublic school if the subject of the  
 10 request is expected to have direct, ongoing contact with school  
 11 children within the scope of the individual's employment;**
- 12 **(10) has volunteered services at a public school (as defined in  
 13 IC 20-10.1-1-2) or non-public school (as defined in  
 14 IC 20-10.1-1-3) that involve contact with, care of, or supervision  
 15 over a student enrolled in the school;**
- 16 ~~(10)~~ **(11)** is being investigated for welfare fraud by an investigator  
 17 of the division of family and children or a county office of family  
 18 and children;
- 19 ~~(11)~~ **(12)** is being sought by the parent locator service of the child  
 20 support bureau of the division of family and children; or
- 21 ~~(12)~~ **(13)** has been convicted of any of the following:
- 22 (A) Rape (IC 35-42-4-1), if the victim is less than eighteen  
 23 (18) years of age.
- 24 (B) Criminal deviate conduct (IC 35-42-4-2), if the victim is  
 25 less than eighteen (18) years of age.
- 26 (C) Child molesting (IC 35-42-4-3).
- 27 (D) Child exploitation (IC 35-42-4-4(b)).
- 28 (E) Possession of child pornography (IC 35-42-4-4(c)).
- 29 (F) Vicarious sexual gratification (IC 35-42-4-5).
- 30 (G) Child solicitation (IC 35-42-4-6).
- 31 (H) Child seduction (IC 35-42-4-7).
- 32 (I) *Sexual misconduct with a minor as a Class A or B felony*  
 33 *(IC 35-42-4-9).*
- 34 (J) Incest (IC 35-46-1-3), if the victim is less than eighteen  
 35 (18) years of age.
- 36 However, limited criminal history information obtained from the  
 37 National Crime Information Center may not be released under this  
 38 section except to the extent permitted by the Attorney General of the

1 United States.

2 (b) A law enforcement agency shall allow inspection of a limited  
3 criminal history by and release a limited criminal history to the  
4 following noncriminal justice organizations:

5 (1) Federally chartered or insured banking institutions.

6 (2) Officials of state and local government for *any of the purpose*  
7 *of following purposes:*

8 (A) Employment ~~and~~ with a state or local governmental  
9 entity.

10 (B) Licensing.

11 (3) Segments of the securities industry identified under 15 U.S.C.  
12 78q(f)(2).

13 (c) Any person who uses limited criminal history for any purpose  
14 not specified under this section commits a Class A misdemeanor."

17 **by an entity that seeks to enter into a contract with a school**  
18 **corporation may be required to provide the consent described in**

20 **(5) to either the individual's employer or the school corporation."**

- 2 Page 10, delete line 1.
- 3 Renumber all SECTIONS consecutively.  
(Reference is to SB 207 as introduced.)
