

COMMITTEE REPORT

MR. PRESIDENT:

The Senate Committee on Health and Provider Services, to which was referred House Bill No. 1111, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 1, line 5, after "(c)" insert ",".
- 2 Page 1, line 5, strike "or".
- 3 Page 1, line 5, after "(d)," insert "**or (e),**".
- 4 Page 1, line 9, after "policy" insert "**not described in subsection**
- 5 **(d)**".
- 6 Page 2, delete lines 3 through 19, begin a new line triple block
- 7 indented and insert:
 - 8 "(i) section 24 of this chapter;
 - 9 (ii) IC 27-8-6;
 - 10 (iii) IC 27-8-14;
 - 11 (iv) IC 27-8-23;
 - 12 (v) 760 IAC 1-38.1; and
 - 13 (vi) 760 IAC 1-39.
- 14 **(d) A certificate may be issued to a resident of Indiana under an**
- 15 **association group policy, a discretionary group policy, or a trust**
- 16 **group policy that is delivered or issued for delivery in a state other**
- 17 **than Indiana if:**
 - 18 **(1) the delivery state has a law substantially similar to section**
 - 19 **16 of this chapter;**
 - 20 **(2) the delivery state has approved the group policy; and**

- 1 **(3) the policy or the certificate contains provisions that are:**
- 2 **(A) substantially similar to the provisions required by:**
- 3 **(i) section 19 of this chapter;**
- 4 **(ii) section 21 of this chapter; and**
- 5 **(iii) IC 27-8-5.6; and**
- 6 **(B) consistent with the requirements set forth in:**
- 7 **(i) section 15.6 of this chapter;**
- 8 **(ii) section 24 of this chapter;**
- 9 **(iii) section 26 of this chapter;**
- 10 **(iv) IC 27-8-6;**
- 11 **(v) IC 27-8-14;**
- 12 **(vi) IC 27-8-14.1;**
- 13 **(vii) IC 27-8-14.5;**
- 14 **(viii) IC 27-8-14.7;**
- 15 **(ix) IC 27-8-14.8;**
- 16 **(x) IC 27-8-20;**
- 17 **(xi) IC 27-8-23;**
- 18 **(xii) IC 27-8-24.3;**
- 19 **(xiii) IC 27-8-26;**
- 20 **(xiv) IC 27-8-28;**
- 21 **(xv) IC 27-8-29;**
- 22 **(xvi) 760 IAC 1-38.1; and**
- 23 **(xvii) 760 IAC 1-39."**
- 24 Page 2, line 20, strike "(d)" and insert "(e)".
- 25 Page 2, line 25, strike "(e)" and insert "(f)".
- 26 Page 4, after line 27, begin a new paragraph and insert:
- 27 "SECTION 5. [EFFECTIVE JULY 1, 2002] **(a) The department of**
- 28 **insurance shall:**
- 29 **(1) study the application of the requirements that apply to**
- 30 **group policies specified under IC 27-8-5-16.5(d), as amended**
- 31 **by this act, to additional group policies; and**

- 1 **(2) report the results of the study under subdivision (1) to the**
- 2 **legislative council not later than December 31, 2002.**
- 3 **(b) This SECTION expires June 30, 2003."**
