

**CONFERENCE COMMITTEE REPORT  
DIGEST FOR EHB 1834**

**Synopsis:** Financial institutions. Conference committee report for EHB 1834. Changes the date as of which reference is made to federal laws and regulations. Reduces bond requirements for payday lenders. Defines "month" in the pawnbroker act to ensure consistent calculation of interest. Specifically provides for the right of credit unions to buy and sell assets. Provides for the release of information to state and federal supervisory agencies, federal law enforcement agencies, and federal prosecutorial agencies or offices. Authorizes the department of financial institutions to remove officers, directors, and employees of financial institutions for certain practices, violations, and breaches. Allows the department to make certain final orders public. Requires department approval for reductions in capital stock, capital surplus, and preferred stock levels. Modifies provisions concerning the establishment of trust offices. Prohibits the unauthorized use of: (1) the term banc or banco; and (2) the name of an existing bank or bank holding company or a name confusingly similar to the name of an existing bank or bank holding company. Treats savings associations and savings banks as though they are members of the Federal Reserve System even if they are not members. Requires approval of the department prior to establishing a subsidiary. Modifies the change of control statute. Broadens the ability of banks to invest in Federal Home Loan Bank stock while maintaining a ceiling on such investments. Makes technical corrections. **(This conference committee report provides for the release of information to state and federal supervisory agencies, federal law enforcement agencies, and federal prosecutorial agencies or offices.)**

## CONFERENCE COMMITTEE REPORT

**MR. SPEAKER:**

*Your Conference Committee appointed to confer with a like committee from the Senate upon Engrossed Senate Amendments to Engrossed House Bill No. 1834 respectfully reports that said two committees have conferred and agreed as follows to wit:*

that the House recede from its dissent from all Senate amendments and that the House now concur in all Senate amendments to the bill and that the bill be further amended as follows:

- 1 Delete everything after the enacting clause and insert the following:
- 2 SECTION 1. IC 24-4.5-1-102, AS AMENDED BY P.L.82-2002,
- 3 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 4 JULY 1, 2003]: Sec. 102. Purposes; Rules of Construction)(1) This
- 5 article shall be liberally construed and applied to promote its
- 6 underlying purposes and policies.
- 7 (2) The underlying purposes and policies of this article are:
- 8 (a) to simplify, clarify, and modernize the law governing retail
- 9 installment sales, consumer credit, small loans, and usury;
- 10 (b) to provide rate ceilings to assure an adequate supply of credit
- 11 to consumers;
- 12 (c) to further consumer understanding of the terms of credit
- 13 transactions and to foster competition among suppliers of
- 14 consumer credit so that consumers may obtain credit at reasonable
- 15 cost;
- 16 (d) to protect consumer buyers, lessees, and borrowers against
- 17 unfair practices by some suppliers of consumer credit, having due
- 18 regard for the interests of legitimate and scrupulous creditors;
- 19 (e) to permit and encourage the development of fair and

1 economically sound consumer credit practices;  
 2 (f) to conform the regulation of consumer credit transactions to the  
 3 policies of the Federal Consumer Credit Protection Act; and  
 4 (g) to make uniform the law including administrative rules among  
 5 the various jurisdictions.

6 (3) A reference to a requirement imposed by this article includes  
 7 reference to a related rule of the department adopted pursuant to this  
 8 article.

9 (4) A reference to a federal law in IC 24-4.5 is a reference to the law  
 10 in effect December 31, ~~2001~~ **2002**.

11 SECTION 2. IC 24-4.5-7-401, AS ADDED BY P.L.38-2002,  
 12 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 13 JULY 1, 2003]: Sec. 401. (1) Except as provided in subsection (2), a  
 14 small loan may not be made for a term of less than fourteen (14) days.

15 (2) After the consumer's third consecutive small loan, ~~renewal~~;  
 16 another small loan may not be made to that consumer within seven (7)  
 17 days after the date of the third consecutive small loan unless the new  
 18 small loan is for a term of twenty-eight (28) days or longer.

19 SECTION 3. IC 24-4.5-7-413, AS ADDED BY P.L.38-2002,  
 20 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 21 JULY 1, 2003]: Sec. 413. (1) A person engaged in making small loans  
 22 under this chapter shall post a bond to the department in the amount of  
 23 fifty thousand dollars (\$50,000) for each location where small loans  
 24 will be made, up to a maximum bond amount of five hundred thousand  
 25 dollars (\$500,000).

26 (2) A bond posted under subsection (1) must continue in effect for  
 27 ~~five (5)~~ **two (2)** years after the lender ceases operation in Indiana. The  
 28 bond must be available to pay damages and penalties to a consumer  
 29 harmed by a violation of this chapter.

30 SECTION 4. IC 28-1-2-23, AS AMENDED BY P.L.134-2001,  
 31 SECTION 6, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 32 JULY 1, 2003]: Sec. 23. (a) A corporation or an individual acting  
 33 directly, indirectly, or through or in concert with one (1) or more other  
 34 corporations or individuals may not acquire control of any bank, trust  
 35 company, stock savings bank, ~~bank~~ holding company, corporate  
 36 fiduciary, or industrial loan and investment company unless the  
 37 department has received an application for change in control by which  
 38 the department is given one hundred twenty (120) days prior written  
 39 notice of the proposed change in control and within that time the  
 40 department has issued a notice approving the proposed change in  
 41 control. The application shall contain the name and address of the  
 42 corporation, individual, or individuals, who propose to acquire control.

43 (b) The period for approval under subsection (a) may be extended:  
 44 (1) in the discretion of the director for an additional thirty (30)  
 45 days; and  
 46 (2) not to exceed two (2) additional times for not more than  
 47 forty-five (45) days each time if:

48 (A) the department determines that the corporation, individual,  
 49 or individuals, who propose to acquire control have not  
 50 submitted substantial evidence of the qualifications described in  
 51 subsection (c);

1 (B) the department determines that any material information  
2 submitted is substantially inaccurate; or

3 (C) the department has been unable to complete the investigation  
4 of the corporation, individual, or individuals, who propose to  
5 acquire control because of any delay caused by or the inadequate  
6 cooperation of the corporation, individual, or individuals.

7 (c) The department shall issue a notice approving the application  
8 only after it has become satisfied that both of the following apply:

9 (1) The corporation, individual, or individuals who propose to  
10 acquire control are qualified by competence, experience, character,  
11 and financial responsibility to control and operate the bank, trust  
12 company, stock savings bank, bank holding company, corporate  
13 fiduciary, or industrial loan and investment company in a legal and  
14 proper manner.

15 (2) The interests of the stockholders, depositors, and creditors of  
16 the bank, trust company, stock savings bank, bank holding  
17 company, corporate fiduciary, or industrial loan and investment  
18 company and the interests of the public generally will not be  
19 jeopardized by the proposed change in control.

20 (d) As used in this section, "~~bank~~ holding company" means any  
21 company (as defined in IC 28-2-15-5 before July 1, 1992, and as  
22 defined in IC 28-2-16-5 beginning July 1, 1992) that **directly or**  
23 **indirectly** controls one (1) or more state chartered ~~banks~~: **financial**  
24 **institutions**.

25 (e) As used in this section, "control" means the power directly or  
26 indirectly to:

27 (1) direct the management or policies of a bank, a trust company,  
28 a ~~bank~~ holding company, a corporate fiduciary, or an industrial  
29 loan and investment company; or

30 (2) vote at least twenty-five percent (25%) of any class of voting  
31 securities of a bank, a trust company, a ~~bank~~ holding company, a  
32 corporate fiduciary, or an industrial loan and investment company.

33 (f) The president or other chief executive officer of a financial  
34 institution **or holding company** shall report to the director of the  
35 department any transfer or sale of shares of stock of the financial  
36 institution **or holding company** that results in direct or indirect  
37 ownership by a stockholder or an affiliated group of stockholders of at  
38 least ten percent (10%) of the outstanding stock of the financial  
39 institution **or holding company**. The report required by this section  
40 must be made not later than ten (10) days after the transfer of the shares  
41 of stock on the books of the financial institution **or holding company**.

42 SECTION 5. IC 28-1-11-12.5 IS ADDED TO THE INDIANA CODE  
43 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
44 1, 2003]: **Sec. 12.5. Subject to any limitations imposed by the**  
45 **department through policy, a bank or trust company may do any**  
46 **of the following:**

47 (1) **Invest the money deposited in the bank or trust company in**  
48 **the shares of the capital stock, bonds, debentures, notes, or**  
49 **other obligations of a federal home loan bank of the United**  
50 **States.**

51 (2) **Become a member of the federal home loan bank of the**

1 **district in which Indiana is located or an adjoining district.**

2 **(3) Borrow money from:**

3 **(A) a federal home loan bank described in subdivision (2);**

4 **(B) the Federal Deposit Insurance Corporation; or**

5 **(C) any other corporation.**

6 **(4) Transfer, assign to, and pledge with a federal home loan**  
 7 **bank described in subdivision (2), the Federal Deposit**  
 8 **Insurance Corporation, or other corporation any of the bonds,**  
 9 **notes, contracts, mortgages, securities, or any other property**  
 10 **of the bank or trust company held or acquired as security for**  
 11 **the payment of loans entered into under subdivision (3).**

12 **(5) Exercise all rights, powers, and privileges conferred upon,**  
 13 **and do all things and perform all acts required of, members or**  
 14 **shareholders of a federal home loan bank by the Federal Home**  
 15 **Loan Bank Act (12 U.S.C. 1421 through 1449).**

16 SECTION 6. IC 28-1-20-4, IS AMENDED TO READ AS  
 17 FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 4. (a) Except as  
 18 provided in subsections (c), (d), (g), and (k), it is unlawful for any  
 19 person, firm, limited liability company, or corporation (other than a  
 20 bank or trust company, **bank holding company**, or corporate fiduciary  
 21 organized or reorganized under IC 28 or statutes in effect at the time of  
 22 organization or reorganization or under the laws of the United States):

23 (1) to use the word "bank", **banc, or banco** as a part of the name  
 24 or title of the person, firm, or corporation; or

25 (2) to advertise or represent the person, firm, limited liability  
 26 company, or corporation to the public:

27 (A) as a bank or trust company or a corporate fiduciary; or

28 (B) as affording the services or performing the duties which by  
 29 law only a bank or trust company or a corporate fiduciary is  
 30 entitled to afford and perform.

31 (b) A financial institution organized under the laws of any state or the  
 32 United States that establishes a branch office under this title is  
 33 authorized to do business at that branch using a name other than the  
 34 name of its home office.

35 (c) Notwithstanding the prohibitions of this section, an out-of-state  
 36 financial institution with the word "bank" in its legal name may use the  
 37 word "bank" if the financial institution is insured by the Federal  
 38 Deposit Insurance Corporation or its successor.

39 (d) Notwithstanding subsection (a), a building and loan association  
 40 organized under IC 28-4 (before its repeal) may include in its name or  
 41 title:

42 (1) the words "savings bank"; or

43 (2) the word "bank" if the name or title also includes either the  
 44 words "savings bank" or letters "SB".

45 A building and loan association that includes "savings bank" in its title  
 46 under this section does not by that action become a savings bank for  
 47 purposes of IC 28-6.1.

48 (e) The name or title of a savings bank governed by IC 28-6.1 must  
 49 include the words "savings bank" or the letters "SB".

50 (f) A savings association may include in its name the words "building  
 51 and loan association".

1 (g) Notwithstanding subsection (a), a bank holding company (as  
2 defined in 12 U.S.C. 1841) may use the word "bank" or "banks" as a  
3 part of its name. However, this subsection does not permit a bank  
4 holding company to advertise or represent itself to the public as  
5 affording the services or performing the duties that by law a bank or  
6 trust company only is entitled to afford and perform.

7 (h) The department is authorized to investigate the business affairs  
8 of any person, firm, limited liability company, or corporation that uses  
9 "bank", **banc, or banco** in its title or holds itself out as a bank,  
10 corporate fiduciary, or trust company for the purpose of determining  
11 whether the person, firm, limited liability company, or corporation is  
12 violating any of the provisions of this article, and, for that purpose, the  
13 department and its agents shall have access to any and all of the books,  
14 records, papers, and effects of the person, firm, limited liability  
15 company, or corporation. In making its examination, the department  
16 may examine any person and the partners, officers, members, or agents  
17 of the firm, limited liability company, or corporation under oath,  
18 subpoena witnesses, and require the production of the books, records,  
19 papers, and effects considered necessary. On application of the  
20 department, the circuit or superior court of the county in which the  
21 person, firm, limited liability company, or corporation maintains a  
22 place of business shall, by proper proceedings, enforce the attendance  
23 and testimony of witnesses and the production and examination of  
24 books, papers, records, and effects.

25 (i) The department is authorized to exercise the powers under  
26 IC 28-11-4 against a person, firm, limited liability company, or  
27 corporation that improperly holds itself out as a financial institution.

28 (j) A person, firm, limited liability company, or corporation who  
29 violates this section is subject to a penalty of ~~two~~ **five** hundred dollars  
30 ~~(\$200)~~ **(\$500)** per day for each and every day during which the  
31 violation continues. The penalty imposed shall be recovered in the  
32 name of the state on relation of the department and, when recovered,  
33 shall be paid into the financial institutions fund established by  
34 IC 28-11-2-9.

35 (k) The word "bank", **banc, or banco** may not be included in the  
36 name of a corporate fiduciary.

37 **(l) A person, firm, limited liability company, or corporation may**  
38 **not use the name of an existing bank or bank holding company or**  
39 **a name confusingly similar to that of an existing bank or bank**  
40 **holding company when marketing to or soliciting business from a**  
41 **customer or prospective customer if the reference to the existing**  
42 **bank or bank holding company is:**

43 **(1) without the consent of the existing bank or bank holding**  
44 **company; and**

45 **(2) in a manner that could cause a reasonable person to believe**  
46 **that the marketing material or solicitation:**

47 **(A) originated from;**

48 **(B) is endorsed by; or**

49 **(C) is in any other way the responsibility of;**

50 **the existing bank or bank holding company.**

51 **(m) An existing bank or bank holding company may, in addition**

1 to any other remedies available under the law, report an alleged  
 2 violation of subsection (l) to the department. If the department  
 3 finds that the marketing material or solicitation in question is in  
 4 violation of subsection (l), the department may direct the person,  
 5 firm, limited liability company, or corporation to cease and desist  
 6 from using that marketing material or solicitation in Indiana. If  
 7 that person, firm, limited liability company, or corporation persists  
 8 in using the marketing material or solicitation, the department  
 9 may impose a civil penalty of up to fifteen thousand dollars  
 10 (\$15,000) for each violation. Each instance in which the marketing  
 11 material or solicitation is sent to a customer or prospective  
 12 customer constitutes a separate violation of subsection (l).

13 (n) Nothing in subsection (l) or (m) prohibits the use of or  
 14 reference to the name of an existing bank or bank holding company  
 15 in marketing materials or solicitations, if the use or reference does  
 16 not deceive or confuse a reasonable person regarding whether the  
 17 marketing material or solicitation:

18 (1) originated from;

19 (2) is endorsed by; or

20 (3) is in any other way the responsibility of;  
 21 the existing bank or bank holding company.

22 (o) The department may adopt rules under IC 4-22-2 to  
 23 implement this section.

24 SECTION 7. IC 28-2-13-26 IS AMENDED TO READ AS  
 25 FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 26. (a) A bank, trust  
 26 company, corporate fiduciary, or savings bank **organized under the**  
 27 **laws of Indiana** may establish a trust office to exercise its powers as  
 28 a fiduciary **to conduct business** in any location that is approved by the  
 29 department. Before the department approves a trust office **to exercise**  
 30 **powers as a fiduciary** under this subsection, it must determine to its  
 31 satisfaction that the bank, trust company, corporate fiduciary, or  
 32 savings bank will have adequate capital, sound management, and  
 33 adequate future earnings prospects after the establishment of the trust  
 34 office.

35 (b) A trust office established under this section by a bank, trust  
 36 company, or savings bank shall not:

37 (1) receive deposits;

38 (2) pay checks; or

39 (3) lend money;

40 at the trust office.

41 SECTION 8. IC 28-6.1-8-8 IS AMENDED TO READ AS  
 42 FOLLOWS [EFFECTIVE JULY 1, 2003]: Sec. 8. **Subject to any**  
 43 **limitations imposed by the department through policy, a** savings  
 44 bank may do any of the following:

45 (1) Invest the money deposited in the savings bank in the shares of  
 46 the capital stock, bonds, debentures, notes, or other obligations of  
 47 a federal home loan bank of the United States.

48 (2) Become a member of the federal home loan bank of this or an  
 49 adjoining district.

50 (3) Borrow money from:

51 (A) a bank described in subdivision (2);

- 1 (B) the Federal Deposit Insurance Corporation; or  
 2 (C) any other corporation.
- 3 (4) Transfer, assign to, and pledge with a bank described in  
 4 subdivision (2), the Federal Deposit Insurance Corporation, or  
 5 other corporation, any of the bonds, notes, contracts, mortgages,  
 6 securities, or other property of the savings bank held or acquired,  
 7 as security for the payment of loans entered into under subdivision  
 8 (3).
- 9 (5) Exercise all rights, powers, and privileges conferred upon, and  
 10 to do all things and perform all acts required of, members or  
 11 shareholders of a federal home loan bank by the Federal Home  
 12 Loan Bank Act (12 U.S.C. 1421 through 1449).
- 13 SECTION 9. IC 28-6.1-20 IS ADDED TO THE INDIANA CODE  
 14 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE  
 15 JULY 1, 2003]:
- 16 **Chapter 20. Applicability of the Federal Reserve Act**
- 17 **Sec. 1. For purposes of this article, a savings bank that is not a**  
 18 **member of the Federal Reserve System is subject to Sections 23A**  
 19 **and 23B of the Federal Reserve Act (12 U.S.C. 371c or 371c-1) to**  
 20 **the same extent and in the same manner as if the savings bank were**  
 21 **a member of the Federal Reserve System.**
- 22 **Sec. 2. A violation of Section 23A or 23B of the Federal Reserve**  
 23 **Act (12 U.S.C. 371c or 371c-1) by a savings bank or a subsidiary**  
 24 **constitutes a violation of this chapter.**
- 25 SECTION 10. IC 28-7-1-9, AS AMENDED BY P.L.134-2001,  
 26 SECTION 17, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 27 JULY 1, 2003]: Sec. 9. A credit union has the following powers:
- 28 (1) To issue shares of its capital stock to its members. No  
 29 commission or compensation shall be paid for securing members  
 30 or for the sale of shares.
- 31 (2) To make loans to members or other credit unions. A loan to  
 32 another credit union may not exceed twenty percent (20%) of the  
 33 paid-in capital and surplus of the credit union making the loan.
- 34 (3) To make loans to officers, directors, or committee members,  
 35 but only if:
- 36 (A) the loan complies with all requirements under this chapter  
 37 with respect to loans to other borrowers and is not on terms more  
 38 favorable than those extended to other borrowers;
- 39 (B) upon the making of the loan, the aggregate amount of loans  
 40 outstanding under this subdivision will not exceed twenty  
 41 percent (20%) of the unimpaired capital and surplus of the credit  
 42 union;
- 43 (C) the loan is approved by the credit committee or loan officer;  
 44 and
- 45 (D) the borrower takes no part in the consideration of or vote on  
 46 the application.
- 47 (4) To invest in any of the following:
- 48 (A) Bonds, notes, or certificates that are the direct or indirect  
 49 obligations of the United States, or of the state, or the direct  
 50 obligations of a county, township, city, town, or other taxing  
 51 district or municipality or instrumentality of Indiana and that are



- 1 not in default.
- 2 (B) Bonds or debentures issued by the Federal Home Loan Bank  
3 Act (12 U.S.C. 1421 through 1449) or the Home Owners' Loan  
4 Act (12 U.S.C. 1461 through 1468).
- 5 (C) Interest-bearing obligations of the FSLIC Resolution Fund  
6 and obligations of national mortgage associations issued under  
7 the authority of the National Housing Act.
- 8 (D) Mortgages on real estate situated in Indiana which are fully  
9 insured under Title 2 of the National Housing Act (12 U.S.C.  
10 1707 through 1715z).
- 11 (E) Obligations issued by farm credit banks and banks for  
12 cooperatives under the Farm Credit Act of 1971 (12 U.S.C. 2001  
13 through 2279aa-14).
- 14 (F) In savings and loan associations, other credit unions that are  
15 insured under IC 28-7-1-31.5 and certificates of indebtedness or  
16 investment of an industrial loan and investment company if the  
17 association or company is federally insured. Not more than  
18 twenty percent (20%) of the assets of a credit union may be  
19 invested in the shares or certificates of an association or  
20 company; nor more than forty percent (40%) in all such  
21 associations and companies.
- 22 (G) Corporate credit unions.
- 23 (H) Federal funds or similar types of daily funds transactions  
24 with other financial institutions.
- 25 (I) Mutual funds created and controlled by credit unions, credit  
26 union associations, or their subsidiaries. Mutual funds referred  
27 to in this clause may invest only in instruments that are approved  
28 for credit union purchase under this chapter.
- 29 (J) Shares, stocks, or obligations of any credit union service  
30 organization (as defined in Section 712 of the Rules and  
31 Regulations of the National Credit Union Administration) with  
32 the approval of the department. Not more than five percent (5%)  
33 of the total paid in and unimpaired capital of the credit union  
34 may be invested under this clause.
- 35 (5) To deposit its funds into:
- 36 (A) depository institutions that are federally insured; or  
37 (B) state chartered credit unions that are privately insured by an  
38 insurer approved by the department.
- 39 (6) To purchase, hold, own, or convey real estate as may be  
40 conveyed to the credit union in satisfaction of debts previously  
41 contracted or in exchange for real estate conveyed to the credit  
42 union.
- 43 (7) To own, hold, or convey real estate as may be purchased by the  
44 credit union upon judgment in its favor or decrees of foreclosure  
45 upon mortgages.
- 46 (8) To issue shares of stock and upon the terms, conditions,  
47 limitations, and restrictions and with the relative rights as may be  
48 stated in the bylaws of the credit union, but no stock may have  
49 preference or priority over the other to share in the assets of the  
50 credit union upon liquidation or dissolution or for the payment of  
51 dividends except as to the amount of the dividends and the time for

- 1 the payment of the dividends as provided in the bylaws.
- 2 (9) To charge the member's share account for the actual cost of  
3 necessary locator service when the member has failed to keep the  
4 credit union informed about the member's current address. The  
5 charge shall be made only for amounts paid to a person or concern  
6 normally engaged in providing such service, and shall be made  
7 against the account or accounts of any one (1) member not more  
8 than once in any twelve (12) month period.
- 9 (10) To transfer to an accounts payable, a dormant account, or a  
10 special account share accounts which have been inactive, except  
11 for dividend credits, for a period of two (2) years. The credit union  
12 shall not consider the payment of dividends on the transferred  
13 account.
- 14 (11) To invest in fixed assets with the funds of the credit union. An  
15 investment in fixed assets in excess of five percent (5%) of its  
16 assets is subject to the approval of the department.
- 17 (12) To establish branch offices, upon approval of the department,  
18 provided that all books of account shall be maintained at the  
19 principal office.
- 20 (13) To pay an interest refund on loans proportionate to the interest  
21 paid during the dividend period by borrowers who are members at  
22 the end of the dividend period.
- 23 (14) To purchase life savings and loan protection insurance for the  
24 benefit of the credit union and its members, if:
- 25 (A) the coverage is placed with an insurance company licensed  
26 to do business in Indiana; and
- 27 (B) no officer, director, or employee of the credit union  
28 personally benefits, directly or indirectly, from the sale or  
29 purchase of the coverage.
- 30 (15) To sell and cash negotiable checks, travelers checks, and
