MR. SPEAKER:

*Your Committee on **Elections and Apportionment**, to which was referred House Bill 1541, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

 7 system.
- 8 **(2) After December 31, 2005, as provided in 42 U.S.C. 15481:**
- 9 **(A) the total combination of mechanical,**
 10 **electromechanical, or electronic equipment (including the**
 11 **software, firmware, and documentation required to**
 12 **program, control, and support that equipment) that is**
 13 **used:**
- 14 **(i) to define ballots;**
 15 **(ii) to cast and count votes;**
 16 **(iii) to report or display election results; and**
 17 **(iv) to maintain and produce any audit trail information;**
 18 **and**
- 19 **(B) the practices and associated documentation used:**
- 20 **(i) to identify system components and versions of those**
 21 **components;**
 22 **(ii) to test the system during its development and**
 23 **maintenance;**
 24 **(iii) to maintain records of system errors and defects;**
 25 **(iii) to determine specific system changes to be made to**
 26 **a system after the initial qualification of the system; and**
 27 **(iv) to make available any materials to the voter (such as**
 28 **notices, instructions, forms, or paper ballots)."**

- 34 **(C) If the voter selects votes for more than one (1)**
35 **candidate for a single office, the voting system must:**
- 36 **(i) notify the voter that the voter has selected more than**
37 **one (1) candidate for a single office on the ballot;**
38 **(ii) notify the voter before the ballot is cast and counted**

1 of the effect of casting multiple votes for the office; and
2 (iii) provide the voter with the opportunity to correct the
3 ballot before the ballot is cast and counted.

4 A voting system must ensure that any notification required
5 under this clause preserves the privacy of the voter and the
6 confidentiality of the ballot.

7 (3) A voting system must produce a record with an audit
8 capacity for the voting system that satisfies the following:

9 (A) The voting system must produce a permanent paper
10 record with a manual audit capacity for the voting system.

11 (B) The voting system must provide the voter with an
12 opportunity to change the ballot or correct any error
13 before the permanent paper record is produced.

14 (C) The paper record produced under clause (A) must be
15 available as an official record for any recount conducted
16 with respect to any election in which the voting system is
17 used.

18 (4) A voting system must provide alternative language
19 accessibility under the requirements of 42 U.S.C. 1973aa-1a.

20 (5) The error rate of a voting system in counting ballots
21 (determined by taking into account only those errors that are
22 attributable to the voting system and not attributable to an
23 act of the voter) must comply with the error rate standards
24 established by the voting systems standards approved by the
25 Federal Election Commission on April 30, 2002."
