DIGEST OF INTRODUCED BILL

Citations Affected: IC 9-18; IC 9-29-5-34.5.

Synopsis: In God We Trust license plate. Creates an In God We Trust license plate and specifies that it is not a special group recognition license plate. Removes a reference to an obsolete license plate and repeals the statute creating the obsolete license plate.

Effective: July 1, 2003.

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 9-18-15-1, AS AMENDED BY P.L.222-1999,
2 SECTION 9, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2003]: Sec. 1. (a) A person who is the registered owner or
4 lessee of a:
5 (1) passenger motor vehicle;
6 (2) motorcycle;
7 (3) recreational vehicle; or
8 (4) vehicle registered as a truck with a declared gross weight of
9 not more than:
10 (A) eleven thousand (11,000) pounds;
11 (B) nine thousand (9,000) pounds; or
12 (C) seven thousand (7,000) pounds;
13 registered with the bureau or who makes an application for an original
14 registration or renewal registration of a vehicle may apply to the bureau
15 for a personalized license plate to be affixed to the vehicle for which
16 registration is sought instead of the regular license plate.
17 (b) A person who:

 40 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE

42 **Chapter 24.5. In God We Trust License Plates**

1 **Sec. 1. The bureau shall design an In God We Trust license plate**
 2 **to be issued beginning January 1, 2004.**

3 **Sec. 2. An In God We Trust license plate must include the**
 4 **following:**

5 **(1) A basic design for the plate with consecutive numbers or**
 6 **letters, or both, to properly identify the vehicle.**

7 **(2) A background design, an emblem, or colors that designate**
 8 **the license plate as an In God We Trust license plate.**

9 **(3) Any other information the bureau considers necessary.**

10 **Sec. 3. A license plate issued under this chapter may be**
 11 **displayed on the following:**

12 **(1) A passenger motor vehicle.**

13 **(2) A truck registered as a truck with a declared gross weight**
 14 **of not more than eleven thousand (11,000) pounds.**

15 **(3) A recreational vehicle.**

16 **Sec. 4. A person who is a resident of Indiana and who is eligible**
 17 **to register and display a license plate upon a vehicle under this title**
 18 **may apply for and receive one (1) or more In God We Trust license**
 19 **plates after December 31, 2003, upon doing the following:**

20 **(1) Completing an application for an In God We Trust license**
 21 **plate.**

22 **(2) Paying the fee under section 5 of this chapter.**

23 **Sec. 5. The fee for an In God We Trust license plate is the**
 24 **appropriate fee under IC 9-29-5-34.5.**

25 SECTION 3. IC 9-18-25-1, AS AMENDED BY P.L.222-1999,
 26 SECTION 10, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 27 JULY 1, 2003]: Sec. 1. This chapter does not apply to the following:

28 (1) Antique motor vehicle license plates (IC 9-18-12).

29 (2) Recovery vehicle license plates (IC 9-18-13).

30 (3) Personalized license plates (IC 9-18-15).

31 (4) Prisoner of war license plates (IC 9-18-17).

32 (5) Disabled veteran license plates (IC 9-18-18).

33 (6) Purple Heart license plates (IC 9-18-19).

34 (7) Indiana National Guard license plates (IC 9-18-20).

35 (8) Person with a disability license plates (IC 9-18-22).

36 (9) Amateur radio operator license plates (IC 9-18-23).

37 **(10) In God We Trust license plates (IC 9-18-24.5).**

38 **(11) Pearl Harbor survivor license plates (IC 9-18-45.8).**

39 SECTION 4. IC 9-29-5-34.5 IS ADDED TO THE INDIANA CODE
 40 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY**
 41 **1, 2003]: Sec. 34.5. A vehicle registered under IC 9-18-24.5 is**
 42 **subject to an annual registration fee and any other fee or tax**
