

HOUSE BILL No. 1439

DIGEST OF INTRODUCED BILL

Citations Affected: IC 13-17-5.

Synopsis: Termination of emissions testing program. Prohibits the air pollution control board from adopting rules to require motor vehicle emissions testing in Clark, Floyd, Porter, and Lake counties. Voids the current rule that requires such testing. Repeals a reference to emissions inspection stations in Clark and Floyd counties.

Effective: July 1, 2003.

HOUSE BILL No. 1439



A BILL FOR AN ACT to amend the Indiana Code concerning environmental law.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 13-17-5-9 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2003]: **Sec. 9. (a) The board may not adopt a rule under air
4 pollution control laws that requires motor vehicles to undergo a
5 periodic test of emission characteristics in the following counties:**
6 (1) A county having a population of more than seventy
7 thousand (70,000) but less than seventy-one thousand
8 (71,000).
9 (2) A county having a population of more than ninety
10 thousand (90,000) but less than one hundred thousand
11 (100,000).
12 (3) A county having a population of more than one hundred
13 forty-five thousand (145,000) but less than one hundred
14 forty-eight thousand (148,000).
15 (4) A county having a population of more than four hundred
16 thousand (400,000) but less than seven hundred thousand
17 (700,000).
