SENATE BILL No. 191

A BILL FOR AN ACT to amend the Indiana Code concerning state and local administration.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 4-12-1-11.5 IS ADDED TO THE INDIANA CODE
- 2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE
- 3 UPON PASSAGE]: **Sec. 11.5. For purposes of any statute that**
- 4 **requires budget committee review before an action may be taken**
- 5 **by a state agency or other entity, budget committee review is**
- 6 **considered to have taken place when the action requiring review**
- 7 **has been included on an approved agenda of the budget committee**
- 8 **in the part of the agenda concerning review items.**
- 9 SECTION 2. **An emergency is declared for this act.**

Mr. President: The Senate Committee on Finance, to which was referred Senate Bill No. 191, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

Page 1, line 3, delete "(a) Whenever budget committee" and insert **"For purposes of any statute that requires budget committee review before an action may be taken by a state agency or other entity, budget committee review is considered to have taken place when the action requiring review has been included on an approved agenda of the budget committee in the part of the agenda concerning review items."**

Page 1, delete lines 4 through 17.

Page 2, delete lines 1 through 2.
