

**CONFERENCE COMMITTEE REPORT  
DIGEST FOR EHB 1515**

**Citations Affected:** IC 25-1; IC 25-20.2; IC 25-34.1; IC 34-30-2-98.8.

**Synopsis:** Licensure of home inspectors and fraud investigation. Conference committee report for EHB 1515. Establishes the home inspectors licensing board to regulate home inspectors. Establishes requirements for licensed home inspectors. Provides that a person who performs home inspections for compensation without a license commits a Class B infraction. Provides that a civil action based upon the professional services of a licensed home inspector must be filed within two years after the date the cause of action accrues. Requires the real estate appraiser licensure and certification board to recommend a new fee to be imposed upon licensed or certified appraisers to fund the investigation of real estate or appraisal fraud. Establishes the investigative fund to be jointly administered by the attorney general and the professional licensing board. **(This conference committee report does the following: (1) Requires the real estate appraiser licensure and certification board to recommend a new fee of not more than ten dollars (\$10) to be imposed upon licensed or certified appraisers to fund the investigation of real estate or appraisal fraud. (2) Establishes the investigative fund to be jointly administered by the attorney general and the professional licensing board. (3) Provides that money from the investigative fund is continually appropriated for use by the attorney general and the professional licensing agency. (4) Makes technical corrections.)**

**Effective:** Upon passage; July 1, 2003.

 22 **estate broker, broker-salesperson, or salesperson and is acting**  
 23 **within the scope of the individual's license.**

24 **(4) An individual who is licensed or certified under IC 25-34.1**  
 25 **as a real estate appraiser and is acting within the scope of the**  
 26 **individual's license or certificate.**

27 **(5) An individual who holds a certificate of authority under**  
 28 **IC 27-1-27-2 as a public adjuster and is acting within the scope**

39 **Chapter 2. Definitions**

40 **Sec. 1. The definitions in this chapter apply throughout this**  
 41 **article.**

42 **Sec. 2. "Agency" refers to the Indiana professional licensing**  
 43 **agency established by IC 25-1-6-3.**

44 **Sec. 3. "Applicant" means an individual who applies for a license**  
 45 **as a home inspector.**

46 **Sec. 4. "Board" refers to the home inspectors licensing board**  
 47 **established by IC 25-20.2-3-1.**

48 **Sec. 5. "Client" means an individual who hires or seeks to hire a**  
 49 **licensed home inspector to obtain a home inspection or home**  
 50 **inspection report.**

51 **Sec. 6. "Home inspection" means a visual analysis for the**



1 purpose of providing a professional opinion of the condition of a  
 2 residential dwelling and the dwelling's carports or garages, any  
 3 reasonably accessible installed components, and the operation of  
 4 the dwelling's systems, including any controls normally operated  
 5 by the owner of the dwelling, for the following components:

- 6 (1) Heating systems.
- 7 (2) Cooling systems.
- 8 (3) Electrical systems.
- 9 (4) Plumbing systems.
- 10 (5) Structural components.
- 11 (6) Foundations.
- 12 (7) Roof coverings.
- 13 (8) Exterior and interior components.
- 14 (9) Any other site aspects that affect the residential dwelling.

15 The term does not include a code compliance inspection.

16 Sec. 7. "Home inspection report" means a legibly written report  
 17 prepared for compensation and issued after a home inspection. The  
 18 report must include the following:

19 (1) A report on any system or component inspected that, in the  
 20 professional opinion of the inspector, is significantly deficient  
 21 or near the end of the system or component's service life. A  
 22 report under this subdivision must include the reason why the  
 23 system or component is significantly deficient or near the end  
 24 of the system or component's service life, unless the reason is  
 25 self-evident.

26 (2) The inspector's recommendation to remedy or monitor a  
 27 deficiency reported under subdivision (1).

28 (3) A list of any systems or components that were designated  
 29 for inspection in the standards of performance adopted by the  
 30 board but that were not inspected.

31 (4) The reason a system or component listed under subdivision  
 32 (3) was not inspected.

33 (5) A statement that the report does not address environmental  
 34 hazards, including:

35 (A) lead-based paint;

36 (B) radon;

37 (C) asbestos;

38 (D) cockroaches;

39 (E) rodents;

40 (F) pesticides;

41 (G) treated lumber;

42 (H) mold;

43 (I) mercury;

44 (J) carbon monoxide; or

45 (K) other similar environmental hazards.

46 (6) A statement that the report does not address wood  
 47 destroying insects and organisms.

48 (7) A statement that the report does not address subterranean  
 49 systems or system components (operational or nonoperational),  
 50 including:

51 (A) sewage disposal;

- 1           **(B) water supply; or**  
 2           **(C) fuel storage or delivery.**

3           **Sec. 8. "Licensed home inspector" means an individual who is**  
 4 **licensed under this article as a home inspector.**

5           **Sec. 9. "Licensee" means a person who performs home**  
 6 **inspections and who is licensed under this article as a home**  
 7 **inspector.**

8           **Sec. 10. "Residential dwelling" means a structure consisting of**  
 9 **at least one (1) but not more than five (5) units, each designed for**  
 10 **occupancy by a single family, whether the units are occupied or**  
 11 **unoccupied.**

12           **Chapter 3. Home Inspectors Licensing Board**

13           **Sec. 1. The home inspectors licensing board is established.**

14           **Sec. 2. (a) The board is composed of seven (7) members**  
 15 **appointed by the governor as follows:**

16           **(1) Four (4) members, each of whom:**

- 17           **(A) is licensed in Indiana as a home inspector; and**  
 18           **(B) has been actively engaged in performing home**  
 19 **inspections in Indiana for at least five (5) years immediately**  
 20 **before the member's appointment to the board.**

21           **(2) One (1) member who:**

- 22           **(A) is a home builder; and**  
 23           **(B) has been actively engaged in home building in Indiana**  
 24 **for at least five (5) years immediately before the member's**  
 25 **appointment to the board.**

26           **(3) One (1) member who:**

- 27           **(A) is a licensed real estate salesperson under**  
 28 **IC 25-34.1-3-3.1 or a licensed real estate broker under**  
 29 **IC 25-34.1-3-4.1; and**  
 30           **(B) has been actively engaged in selling, trading, exchanging,**  
 31 **optioning, leasing, renting, managing, listing, or appraising**  
 32 **residential real estate in Indiana for at least five (5) years**  
 33 **immediately before the member's appointment to the board.**

34           **(4) One (1) member who represents the public at large and is**  
 35 **not associated with the home inspection, home building, or real**  
 36 **estate business other than as a consumer.**

37           **(b) The members of the board must be residents of Indiana.**

38           **Sec. 3. (a) Each member of the board serves a term of three (3)**  
 39 **years and until a successor is appointed and qualified.**

40           **(b) The governor may remove a board member at any time for**  
 41 **incompetency, neglect of duty, or unprofessional conduct.**

42           **(c) If a vacancy occurs in the membership of the board, the**  
 43 **governor shall appoint an individual to serve for the remainder of**  
 44 **the unexpired term.**

45           **(d) A member may not serve on the board for more than six (6)**

 37 **interest of the licensee that may affect the client in connection**  
 38 **with any work for which the licensee is responsible.**

39           **(6) Knowingly making a false or misleading representation**  
 40 **about:**

41               **(A) the condition of a residential dwelling for which the**  
 42 **licensee has performed or has contracted to perform a home**  
 43 **inspection; or**

44               **(B) the extent of the services the licensee has performed or**  
 45 **will perform.**

46           **(7) Committing a felony in the course of the practice of home**  
 47 **inspection or committing any act constituting a violation of**  
 48 **IC 25-20.2-5-2(a)(1)(C).**

49           **(8) Violating any provisions of this article or rules adopted by**  
 50 **the board under this article.**

51           **(9) Making a false or misleading representation:**

- 1           **(A) in a license or renewal application form; or**  
 2           **(B) in information provided to the board.**  
 3           **(10) Failing to pay any fees or fines required by this article.**  
 4           **(11) Failing to continuously maintain the insurance or other**  
 5           **evidence of financial responsibility required by this article.**  
 6           **(12) Communicating to the public false or misleading**  
 7           **information about the type of license held by the licensee.**  
 8           **(13) Engaging in a course of lewd or immoral conduct in**  
 9           **connection with the delivery of services to clients.**  
 10           **(14) Failing to complete the continuing education requirements**  
 11           **established by the board.**

12           **Sec. 2. The procedures set forth in IC 4-21.5 govern the board's**  
 13           **conduct of disciplinary hearings.**

50 investigators and other employees to administer and enforce the  
51 provisions of this article and to investigate and prosecute real**

1 **estate fraud and real estate appraisal fraud.**

2 SECTION 14. IC 34-30-2-98.8 IS ADDED TO THE INDIANA  
3 CODE AS A NEW SECTION TO READ AS FOLLOWS  
4 [EFFECTIVE JULY 1, 2003]: **Sec. 98.8. IC 25-20.2-9-1 through**  
5 **IC 25-20.2-9-3 (Concerning actions of home inspectors).**

6 SECTION 15. [EFFECTIVE JULY 1, 2003] (a) As used in this  
7 SECTION, "board" refers to the home inspectors licensing board  
8 established by IC 25-20.2-3-1, as added by this act.

9 (b) An individual who performs home inspections after June 30,  
10 2003, does not violate IC 25-20.2-5-1 or IC 25-20.2-8-5(a)(1), both  
11 as added by this act, and may not be disciplined or sanctioned for  
12 failure to have a home inspector's license if the person obtains a  
13 home inspector's license not later than July 1, 2005.

14 (c) Notwithstanding the requirements of IC 25-20.2-5-2, as added  
15 by this act, before July 1, 2005, the board may issue to an  
16 individual, upon the individual's application and payment of fees,  
17 a home inspector license if the individual:

18 (1) meets the requirements of IC 25-20.2-5-2(a), as added by  
19 this act, excluding IC 25-20.2-5-2(a)(3);

20 (2) has been engaged in the practice of home inspections for at  
21 least six (6) months; and

22 (3) documents the performance of at least twenty-five (25)  
23 home inspections performed for compensation in the previous  
24 twelve (12) months or at least one hundred (100) home  
25 inspections performed for compensation in the individual's  
26 career.

27 (d) The board may consider and accept the successful completion  
28 of equivalent licensing requirements in another state instead of one  
29 (1) or more of the requirements of IC 25-20.2-5-2(a), as added by  
30 this act.

31 (e) This SECTION expires January 1, 2006.

32 SECTION 16. [EFFECTIVE UPON PASSAGE] (a) As used in this  
33 SECTION, "board" refers to the home inspectors licensing board  
34 established by IC 25-20.2-3-1, as added by this act.

35 (b) Before July 1, 2004, the governor shall make the initial  
36 appointments to the board. In making each initial appointment, the  
37 governor shall indicate the length of the term for which the  
38 individual is appointed.

39 (c) Notwithstanding IC 25-20.2-3-3, as added by this act, the  
40 initial terms of office for the seven (7) individuals appointed to the  
41 board by the governor are as follows:

42 (1) Three (3) members for a term of three (3) years.

43 (2) Two (2) members for a term of two (2) years.

44 (3) Two (2) members for a term of one (1) year.

45 (d) The initial terms begin July 1, 2004.

46 (e) An individual who does not meet all the requirements of  
47 IC 25-20.2-5-2(a), as added by this act, may be appointed to the  
48 board under IC 25-20.2-3-2(a)(1), as added by this act, if the  
49 individual:

50 (1) meets the requirements of IC 25-20.2-5-2(a)(1)(A) through  
51 IC 25-20.2-5-2(a)(1)(C), as added by this act;

1           **(2) has been performing home inspections for at least six (6)**  
2           **months immediately before the person's appointment; and**  
3           **(3) documents the performance of at least twenty-five (25)**  
4           **home inspections performed for compensation in the previous**  
5           **twelve (12) months or at least one hundred (100) home**  
6           **inspections performed for compensation in the individual's**  
7           **career.**

8           **(f) A board member appointed in accordance with subsection (e)**  
9           **must obtain the requisite license in accordance with IC 25-20.2-5-2,**  
10           **as added by this act, on or before July 1, 2005. If a board member**  
11           **does not obtain the requisite license on or before July 1, 2005, the**  
12           **board member shall be considered to have resigned from the board**  
13           **on July 1, 2005, and the governor shall fill the vacancy in**  
14           **accordance with IC 25-20.2-3-3(c), as added by this act. If a board**  
15           **member resigns under this SECTION for failure to obtain a home**  
16           **inspector's license, the acts of the board member and the board**  
17           **before July 1, 2005, are legal and valid.**

18           **(g) Not later than January 1, 2005, the board shall adopt rules**  
19           **under IC 4-22-2 to carry out this act.**

20           **(h) This SECTION expires June 30, 2007.**

21           **SECTION 17. An emergency is declared for this act.**
