IC 1-1-3.1-1 through IC 1-1-3.1-5 governs the effectiveness of acts passed over governor's veto. IC 1-1-3.1-4(d) provides that if a provision of the act takes effect on a specified date and approval of the act occurs after the specified date the provision takes effect on July 1 next following approval of the act.
