Citations Affected: IC 11-10.

Synopsis: Goods made by offenders. Provides that furniture produced by persons in state penal institutions may be sold only to state agencies and political subdivisions.

Effective: July 1, 2005.

A BILL FOR AN ACT to amend the Indiana Code concerning corrections.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 11-10-6-5 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE JULY 1, 2005]: Sec. 5. **(a) Except as**
3 **provided in subsection (b)**, goods produced in whole or in part by
4 committed persons in this state may be sold on the open market.

5 **(b) Furniture produced in whole or in part by committed**
6 **persons may be sold only to state agencies and political**
7 **subdivisions.**
