I move that House Bill 1282 be amended to read as follows:

- 1 Page 2, line 1, delete "16" and insert "17".
- 2 Page 2, between lines 6 and 7, begin a new paragraph and insert:
- 3 **"Sec. 9. As used in this chapter, "public transportation service"**
- 4 **refers only to public surface and rail transportation service."**
- 5 Page 2, line 7, delete "9" and insert "10".
- 6 Page 2, line 9, delete "10" and insert "11".
- 7 Page 2, line 11, delete "11" and insert "12".
- 8 Page 2, line 14, delete "12" and insert "13".

- 14 **commuter transportation district under this subsection. In:**
- 15 **(1) the first twenty-four (24) months in which the authority**
- 16 **receives tax revenue under this chapter, money may be**
- 17 **transferred".**

- 19 Page 5, line 5, delete "in the fund".
- 20 Page 5, line 8, delete "." and insert **"; and**
- 21 **(2) a period after the time described in subdivision (1),**
- 22 **money may be transferred to a commuter transportation**
- 23 **district for the commuter transportation district to develop**
- 24 **in the county imposing the tax under this chapter the new**
- 25 **rail corridor designated in the feasibility study funded under**
- 26 **subsection (c)".**
- 27 Page 5, line 8, beginning with "Money" begin a new line blocked left.
- 28 Page 5, line 11, after "sources." insert **"Money transferred under**
- 29 **subdivision (2) may not be used for operating expenditures".**
- 30 Page 5, between lines 36 and 37, begin a new paragraph and insert:
- 31 **"Sec. 20. (a) This subsection applies to money that:**
- 32 **(1) is available in the fund beginning twenty-four (24)**
- 33 **months after the authority begins to receive tax revenue**
- 34 **under this chapter; and**
- 35 **(2) is not required to be deposited in the reserve fund under**
- 36 **section 19 of this chapter.**
- 37 **(b) In addition to any transfer of money under section 19 of**
- 38 **this chapter, the authority may make additional distributions of**
- 39 **money from the fund to a commuter transportation district only**
- 40 **for capital expenditures for new and improved public**
- 41 **transportation services in the county imposing the tax under this**
- 42 **chapter.**
- 43 **(c) Before the authority transfers money under this section,**

1 **the commuter transportation district must submit a written plan**
2 **or amended plan to the authority for its review. The authority**
3 **shall prescribe the format for plans and amended plans. The**
4 **written plan must specify the nature and the amount of the**
5 **proposed expenditures.**

6 **(d) Money transferred under this section may not be used for**
7 **any purpose other than the purposes specified in the plan or**
8 **amended plan."**

9 Page 5, line 37, delete "19" and insert "21".
