Synopsis: State and local administration. Makes the following changes to the sales and use tax: (1) Grants a credit against Indiana use tax for sales tax paid in another state for a vehicle, a watercraft, or an aircraft. (2) Makes the furnishing of satellite television service, cable radio service, and satellite radio service a retail transaction. (3) Indicates that a deduction for sales tax paid on a purchase price that becomes uncollectible is assignable only if the retail merchant that paid the tax assigned the right to the deduction in writing. (4) Requires certain out-of-state entities to collect sales tax in Indiana. (5) Provides that gross retail income does not include receipts attributable to installation charges if those charges are separately stated on the invoice. Revises the manner in which net operating losses are computed. Makes the research expense credit permanent (instead of expiring at the end of 2013). Repeals the sales tax credit for sales of motor vehicles, trailers, watercraft, and aircraft that are sold in Indiana and titled or registered in another state. Repeals the registration fee for a converter dolly. Repeals the sales tax on complimentary hotel rooms. Makes various changes concerning taxation, economic development, state and local administration, and charity gaming. **(This conference committee report does the following: (1) Restores a provision deleted in the senate that limited the classification of adopted children as Class A transferees for the purposes of the inheritance tax. (2) Adds SB 215 concerning prize limits for charity gaming. (3) Adds SB 272 concerning military bases and economic development (senate passed version plus the certified technology park amendment passed in Ways and Means). (4) Adds SB 201 concerning eminent domain filings. (5) Adds SB 252 concerning unclaimed property resulting from the demutualization of an insurance company. (6) Adds provisions from SB 180 concerning community revitalization enhancement districts. (7) Adds SB 425 concerning early retirees from Muscatatuck. (8) Adds provisions concerning the EDGE credit and certain pass through**

entities. (9) Authorizes the department of revenue to publish on the Internet a list of taxpayers that are subject to tax warrants issued at least 24 months before the date of the publication of the list. (10) Sunsets the authority to publish the list after June 30, 2006. (11) Removes the repeal of the annual fee to renew a permanent registration of a semitrailer. (12) Provides that delivery charges are taxable by removing them from the bill's exclusion from gross retail income. (13) Extends the Hoosier business investment tax credit by two years. (14) Establishes the interim study committee on corporate taxation to study the utilization of passive investment corporations by companies doing business in Indiana. (15) Adds provisions from SB 211 concerning a twenty-first century fund grant office. (16) Adds the senate passed version of SB 47 creating the emerging technology grant fund to be administered by the twenty-first century research and technology fund board. (17) Adds SB 151 concerning local rainy day funds. (18) Adds SB 149 concerning borrowing for local public works. (19) Adds provisions from SB 281 concerning property tax abatement but limits the application to a particular locality. (20) Adds SB 274 concerning an optional property tax abatement fee. (21) Removes provisions concerning farmland preservation. (22) Adds a provision concerning the assessment of Section 42 low income housing.)

Your Conference Committee appointed to confer with a like committee from the Senate upon Engrossed Senate Amendments to Engrossed House Bill No. 1365 respectfully reports that said two committees have conferred and agreed as follows to wit:

that the House recede from its dissent from all Senate amendments and that the House now concur in all Senate amendments to the bill and that the bill be further amended as follows:

- 1 Delete the title and insert the following:
- 2 A BILL FOR AN ACT to amend the Indiana Code concerning state
- 3 and local administration and to make an appropriation.
- 4 Delete everything after the enacting clause and insert the following:
- 5 SECTION 1. IC 4-32-9-33 IS AMENDED TO READ AS FOLLOWS
- 6 [EFFECTIVE JULY 1, 2004]: Sec. 33. (a) The total prizes awarded for
- 7 one (1) pull tab, punchboard, or tip board game may not exceed ~~two~~
- 8 **five** thousand dollars ~~(\$2,000)~~. **(\$5,000)**.
- 9 (b) A single prize awarded for one (1) winning ticket in a pull tab,
- 10 punchboard, or tip board game may not exceed ~~three~~ **five** hundred
- 11 **ninety-nine** dollars ~~(\$300)~~. **(\$599)**.
- 12 (c) The selling price for one (1) ticket for a pull tab, punchboard, or
- 13 tip board game may not exceed one dollar (\$1).
- 14 SECTION 2. IC 6-2.5-1-5, AS AMENDED BY P.L.257-2003,
- 15 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 16 UPON PASSAGE]: Sec. 5. (a) Except as provided in subsection (b),
- 17 "gross retail income" means the total gross receipts, of any kind or

1 character, received in a retail transaction, including cash, credit,
 2 property, and services, for which tangible personal property is sold,
 3 leased, or rented, valued in money, whether received in money or
 4 otherwise, without any deduction for:

- 5 (1) the seller's cost of the property sold;
- 6 (2) the cost of materials used, labor or service cost, interest, losses,
 7 all costs of transportation to the seller, all taxes imposed on the
 8 seller, and any other expense of the seller;
- 9 (3) charges by the seller for any services necessary to complete the
 10 sale, other than delivery and installation charges;
- 11 (4) delivery charges; **or**
- 12 ~~(5) installation charges; or~~
- 13 ~~(6)~~ **(5)** the value of exempt personal property given to the
 14 purchaser where taxable and exempt personal property have been
 15 bundled together and sold by the seller as a single product or piece
 16 of merchandise.

17 **For purposes of subdivision (4), delivery charges are charges by**
 18 **the seller for preparation and delivery of the property to a location**
 19 **designated by the purchaser of property, including but not limited**
 20 **to transportation, shipping, postage, handling, crating, and**
 21 **packing.**

22 (b) "Gross retail income" does not include that part of the gross
 23 receipts attributable to:

- 24 (1) the value of any tangible personal property received in a like
 25 kind exchange in the retail transaction, if the value of the property
 26 given in exchange is separately stated on the invoice, bill of sale, or
 27 similar document given to the purchaser;
- 28 (2) the receipts received in a retail transaction which constitute
 29 interest, finance charges, or insurance premiums on either a
 30 promissory note or an installment sales contract;
- 31 (3) discounts, including cash, terms, or coupons that are not
 32 reimbursed by a third party that are allowed by a seller and taken by
 33 a purchaser on a sale;
- 34 (4) interest, financing, and carrying charges from credit extended
 35 on the sale of personal property if the amount is separately stated
 36 on the invoice, bill of sale, or similar document given to the
 37 purchaser; **or**
- 38 (5) any taxes legally imposed directly on the consumer that are
 39 separately stated on the invoice, bill of sale, or similar document
 40 given to the purchaser; **or**
- 41 **(6) installation charges that are separately stated on the**
 42 **invoice, bill of sale, or similar document given to the**
 43 **purchaser.**

44 (c) A public utility's or a power subsidiary's gross retail income
 45 includes all gross retail income received by the public utility or power
 46 subsidiary, including any minimum charge, flat charge, membership fee,
 47 or any other form of charge or billing.

48 SECTION 3. IC 6-2.5-3-1 IS AMENDED TO READ AS FOLLOWS
 49 [EFFECTIVE JULY 1, 2004]: Sec. 1. For purposes of this chapter:

1 (a) "Use" means the exercise of any right or power of ownership over
2 tangible personal property.

3 (b) "Storage" means the keeping or retention of tangible personal
4 property in Indiana for any purpose except the subsequent use of that
5 property solely outside Indiana.

6 (c) "A retail merchant engaged in business in Indiana" includes any
7 retail merchant who makes retail transactions in which a person
8 acquires personal property **or services** for use, storage, or
9 consumption in Indiana and who: ~~maintains:~~

10 (1) **maintains** an office, place of distribution, sales location,
11 sample location, warehouse, storage place, or other place of
12 business which is located in Indiana and which the retail merchant
13 maintains, occupies, or uses, either permanently or temporarily,
14 either directly or indirectly, and either by ~~himself~~ **the retail**
15 **merchant** or through ~~an~~ **a representative**, agent, or subsidiary;
16 ~~or~~

17 (2) **maintains** a representative, agent, salesman, canvasser, or
18 solicitor who, while operating in Indiana under the authority of and
19 on behalf of the retail merchant or a subsidiary of the retail
20 merchant, sells, delivers, **installs, repairs, assembles, sets up,**
21 **accepts returns of, bills, invoices,** or takes orders for sales of
22 tangible personal property **or services** to be used, stored, or
23 consumed in Indiana;

24 **(3) is otherwise required to register as a retail merchant**
25 **under IC 6-2.5-8-1; or**

26 **(4) may be required by the state to collect tax under this**
27 **article to the extent allowed under the Constitution of the**
28 **United States and federal law.**

29 (d) Notwithstanding any other provision of this section, tangible or
30 intangible property that is:

31 (1) owned or leased by a person that has contracted with a
32 commercial printer for printing; and

33 (2) located at the premises of the commercial printer;

34 shall not be considered to be, or to create, an office, a place of
35 distribution, a sales location, a sample location, a warehouse, a storage
36 place, or other place of business maintained, occupied, or used in any
37 way by the person. A commercial printer with which a person has
38 contracted for printing shall not be considered to be in any way a
39 representative, an agent, a salesman, a canvasser, or a solicitor for the
40 person.

41 SECTION 4. IC 6-2.5-3-5 IS AMENDED TO READ AS FOLLOWS
42 [EFFECTIVE JULY 1, 2004]: Sec. 5. ~~(a)~~ A person is entitled to a credit
43 against the use tax imposed on the use, storage, or consumption of a
44 particular item of tangible personal property equal to the amount, if any,
45 of sales tax, purchase tax, or use tax paid to another state, territory, or
46 possession of the United States for the acquisition of that property.

47 ~~(b) The credit provided under subsection (a) does not apply to the use~~
48 ~~tax imposed on the use, storage, or consumption of vehicles,~~
49 ~~watercraft, or aircraft that are required to be titled, registered, or~~

1 ~~licensed by Indiana.~~

2 SECTION 5. IC 6-2.5-4-1, AS AMENDED BY P.L.257-2003,
3 SECTION 19, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
4 UPON PASSAGE]: Sec. 1. (a) A person is a retail merchant making a
5 retail transaction when he engages in selling at retail.

6 (b) A person is engaged in selling at retail when, in the ordinary
7 course of his regularly conducted trade or business, he:

8 (1) acquires tangible personal property for the purpose of resale;
9 and

10 (2) transfers that property to another person for consideration.

11 (c) For purposes of determining what constitutes selling at retail, it
12 does not matter whether:

13 (1) the property is transferred in the same form as when it was
14 acquired;

15 (2) the property is transferred alone or in conjunction with other
16 property or services; or

17 (3) the property is transferred conditionally or otherwise.

18 (d) Notwithstanding subsection (b), a person is not selling at retail if
19 he is making a wholesale sale as described in section 2 of this chapter.

20 (e) The gross retail income received from selling at retail is only
21 taxable under this article to the extent that the income represents:

22 (1) the price of the property transferred, without the rendition of
23 any service; and

24 (2) except as provided in subsection (g), any bona fide charges
25 which are made for preparation, fabrication, alteration,
26 modification, finishing, completion, delivery, or other service
27 performed in respect to the property transferred before its transfer
28 and which are separately stated on the transferor's records.

29 ~~For purposes of subdivision (2), charges for delivery are charges by the~~
30 ~~seller for preparation and delivery of the property to a location~~
31 ~~designated by the purchaser of property, including but not limited to~~
32 ~~transportation, shipping, postage, handling, crating, and packing. For~~
33 ~~purposes of this subsection, a transfer is considered to have~~
34 ~~occurred after delivery of the property to the purchaser.~~

35 (f) Notwithstanding subsection (e):

36 (1) in the case of retail sales of gasoline (as defined in
37 IC 6-6-1.1-103) and special fuel (as defined in IC 6-6-2.5-22), the
38 gross retail income received from selling at retail is the total sales
39 price of the gasoline or special fuel minus the part of that price
40 attributable to tax imposed under IC 6-6-1.1, IC 6-6-2.5, or Section
41 4041(a) or Section 4081 of the Internal Revenue Code; and

42 (2) in the case of retail sales of cigarettes (as defined in
43 IC 6-7-1-2), the gross retail income received from selling at retail
44 is the total sales price of the cigarettes including the tax imposed
45 under IC 6-7-1.

46 (g) Gross retail income does not include income that represents
47 charges for serving or delivering food and food ingredients furnished,
48 prepared, or served for consumption at a location, or on equipment,
49 provided by the retail merchant. However, the exclusion under this
50 subsection only applies if the charges for the serving or delivery are

1 stated separately from the price of the food and food ingredients when
2 the purchaser pays the charges.

3 SECTION 6. IC 6-2.5-4-11 IS AMENDED TO READ AS FOLLOWS
4 [EFFECTIVE MARCH 1, 2004 (RETROACTIVE)]: Sec. 11. (a) A
5 person is a retail merchant making a retail transaction when ~~he the~~
6 **person** furnishes ~~local~~ cable television **or radio** service or ~~intrastate~~
7 ~~cable satellite~~ television **or radio** service **that terminates in Indiana.**

8 (b) Notwithstanding subsection (a), a person is not a retail merchant
9 making a retail transaction when the person provides, installs,
10 constructs, services, or removes tangible personal property which is
11 used in connection with the furnishing of ~~local~~ cable television **or radio**
12 service or ~~intrastate cable satellite or radio~~ television service.

13 SECTION 7. IC 6-2.5-6-9, AS AMENDED BY P.L.257-2003,
14 SECTION 30, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
15 JULY 1, 2004]: Sec. 9. (a) In determining the amount of state gross
16 retail and use taxes which ~~he a retail merchant~~ must remit under
17 section 7 of this chapter, ~~a the~~ retail merchant shall, subject to
18 ~~subsection~~ **subsections (c) and (d)**, deduct from ~~his the retail~~
19 **merchant's** gross retail income from retail transactions made during a
20 particular reporting period, an amount equal to ~~his the retail~~
21 **merchant's** receivables which:

22 (1) resulted from retail transactions in which the retail merchant did
23 not collect the state gross retail or use tax from the purchaser;

24 (2) resulted from retail transactions on which the retail merchant
25 has previously paid the state gross retail or use tax liability to the

27 (3) were written off as an uncollectible debt for federal tax
28 purposes under Section 166 of the Internal Revenue Code during

30 (b) If a retail merchant deducts a receivable under subsection (a) and

32 merchant shall, subject to subsection ~~(c)(6); (d)(6)~~, include the amount
33 collected as part of ~~his the retail merchant's~~ gross retail income from
34 retail transactions for the particular reporting period in which ~~he the~~
35 **retail merchant** makes the collection.

36 (c) **This subsection applies only to retail transactions occurring**
37 **after June 30, 2004. The right to a deduction under this section is**
38 **assignable only if the retail merchant that paid the state gross**
39 **retail or use tax liability assigned the right to the deduction in**
40 **writing.**

41 (d) The following provisions apply to a deduction for a receivable
42 treated as uncollectible debt under subsection (a):

43 (1) The deduction does not include interest.

44 (2) The amount of the deduction shall be determined in the manner
45 provided by Section 166 of the Internal Revenue Code for bad
46 debts but shall be adjusted to exclude:

47 (A) financing charges or interest;

48 (B) sales or use taxes charged on the purchase price;

49 (C) uncollectible amounts on property that remain in the

1 possession of the seller until the full purchase price is paid;
 2 (D) expenses incurred in attempting to collect any debt; and
 3 (E) repossessed property.

4 (3) The deduction shall be claimed on the return for the period
 5 during which the receivable is written off as uncollectible in the
 6 claimant's books and records and is eligible to be deducted for
 7 federal income tax purposes. For purposes of this subdivision, a
 8 claimant who is not required to file federal income tax returns may
 9 deduct an uncollectible receivable on a return filed for the period in
 10 which the receivable is written off as uncollectible in the claimant's
 11 books and records and would be eligible for a bad debt deduction
 12 for federal income tax purposes if the claimant were required to file
 13 a federal income tax return.

14 (4) If the amount of uncollectible receivables claimed as a
 15 deduction by a retail merchant for a particular reporting period
 16 exceeds the amount of the retail merchant's taxable sales for that
 17 reporting period, the retail merchant may file a refund claim under
 18 IC 6-8.1-9. However, the deadline for **the** refund claim shall be
 19 measured from the due date of the return for the reporting period
 20 on which the deduction for the uncollectible receivables could first
 21 be claimed.

22 (5) If a retail merchant's filing responsibilities have been assumed
 23 by a certified service provider (as defined in IC 6-2.5-11-2), the
 24 certified service provider may claim, on behalf of the retail
 25 merchant, any deduction or refund for uncollectible receivables
 26 provided by this section. The certified service provider must credit
 27 or refund the full amount of any deduction or refund received to
 28 the retail merchant.

29 (6) For purposes of reporting a payment received on a previously
 30 claimed uncollectible receivable, any payments made on a debt or
 31 account shall be applied first proportionally to the taxable price of
 32 the property and the state gross retail tax or use tax thereon, and
 33 secondly to interest, service charges, and any other charges.

34 (7) A retail merchant claiming a deduction for an uncollectible
 35 receivable may allocate that receivable among the states that are
 36 members of the streamlined sales and use tax agreement if the
 37 books and records of the retail merchant support that allocation.

38 SECTION 8. IC 6-2.5-8-10, AS AMENDED BY P.L.254-2003,
 39 SECTION 5, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 40 JULY 1, 2004]: Sec. 10. (a) A person that:

41 (1) makes retail transactions from outside Indiana to a destination
 42 in Indiana;

43 (2) does not maintain a place of business in Indiana; and

44 (3) either:

45 (A) engages in the regular or systematic soliciting of retail
 46 transactions from potential customers in Indiana;

47 (B) enters into a contract to provide property or services to an
 48 agency (as defined in IC 4-13-2-1) or ~~an~~ **a state educational**
 49 ~~institution of higher education~~ (as defined in IC 20-12-0.5-1); ~~or~~

50 (C) agrees to sell property or services to an agency (as defined

 8 described in subdivision (3)(B) and (3)(C) occurring after June 30,
 9 2003, constitutes consent to be treated under this article as if the person
 10 has a place of business in Indiana or is engaging in conduct described
 11 in subdivision (3)(A), including the provisions of this article that require
 12 a person to collect and remit tax under this article.

13 (b) A person is rebuttably presumed to be engaging in the regular or
 14 systematic soliciting of retail transactions from potential customers in
 15 Indiana if the person does any of the following:

16 (1) Distributes catalogs, periodicals, advertising flyers, or other
 17 written solicitations of business to potential customers in Indiana,
 18 regardless of whether the distribution is by mail or otherwise and
 19 without regard to the place from which the distribution originated
 20 or in which the materials were prepared.

21 (2) Displays advertisements on billboards or displays other outdoor
 22 advertisements in Indiana.

23 (3) Advertises in newspapers published in Indiana.

24 (4) Advertises in trade journals or other periodicals that circulate
 25 primarily in Indiana.

26 (5) Advertises in Indiana editions of a national or regional
 27 publication or a limited regional edition in which Indiana is included
 28 as part of a broader regional or national publication if the
 29 advertisements are not placed in other geographically defined
 30 editions of the same issue of the same publication.

31 (6) Advertises in editions of regional or national publications that
 32 are not by the contents of the editions geographically targeted to
 33 Indiana but that are sold over the counter in Indiana or by
 34 subscription to Indiana residents.

35 (7) Broadcasts on a radio or television station located in Indiana.

36 (8) Makes any other solicitation by telegraphy, telephone, computer
 37 data base, cable, optic, microwave, or other communication
 38 system.

39 (c) A person not maintaining a place of business in Indiana is
 40 considered to be engaged in the regular or systematic soliciting of retail
 41 transactions from potential customers in Indiana if the person engages
 42 in any of the activities described in subsection (b) and:

43 (1) makes at least one hundred (100) retail transactions from
 44 outside Indiana to destinations in Indiana during a period of twelve
 45 (12) consecutive months; or

46 (2) makes at least ten (10) retail transactions totaling more than one
 47 hundred thousand dollars (\$100,000) from outside Indiana to
 48 destinations in Indiana during a period of twelve (12) consecutive
 49 months.

50 (d) **Subject to subsection (e)**, the location in or outside Indiana of

1 vendors that:

2 (1) are independent of a person that is soliciting customers in
3 Indiana; and

4 (2) provide products or services to the person in connection with
5 the person's solicitation of customers in Indiana:

6 (A) including products and services such as creation of copy,
7 printing, distribution, and recording; **but**

9 (i) **delivery of goods;**

15 is not to be taken into account in the determination of whether the
16 person is required to collect use tax under this section.

17 (e) **Subsection (d) does not apply if the person soliciting orders**
18 **is closely related to the vendor.**

19 (f) **For purposes of subsections (a) and (e), a person is closely**
20 **related to another person if:**

21 (1) **the two (2) persons:**

22 (A) **use an identical or a substantially similar name,**
23 **trademark, or good will to develop, promote, or maintain**
24 **sales;**

25 (B) **pay for each other's services in whole or in part**
26 **contingent on the volume or value of sales; or**

27 (C) **share a common business plan or substantially**
28 **coordinate their business plans; and**

29 (2) **either:**

30 (A) **one (1) or both of the persons are corporations and:**

31 (i) **one (1) person; and**

32 (ii) **any other person related to the person in a manner**
33 **that would require an attribution of stock from the**
34 **corporation to the person or from the person to the**
35 **corporation under the attribution rules of Section 318 of**
36 **the Internal Revenue Code;**

37 **own directly, indirectly, beneficially, or constructively at**
38 **least fifty percent (50%) of the value of the corporation's**
39 **outstanding stock;**

40 (B) **both entities are corporations and an individual**
41 **stockholder and the members of the stockholder's family**
42 **(as defined in Section 318 of the Internal Revenue Code)**
43 **own directly, indirectly, beneficially, or constructively a total**
44 **of at least fifty percent (50%) of the value of both entities'**
45 **outstanding stock; or**

46 (C) **one (1) or both persons are limited liability companies,**
47 **partnerships, limited liability partnerships, estates, or**

1 **trusts, and their members, partners, or beneficiaries own**
 2 **directly, indirectly, beneficially, or constructively a total of**
 3 **at least fifty percent (50%) of the profits, capital, stock, or**
 4 **value of one (1) or both persons.**

5 SECTION 9. IC 6-3-1-3.5, AS AMENDED BY P.L.1-2004,
 6 SECTION 49, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 7 JANUARY 1, 2004 (RETROACTIVE)]: Sec. 3.5. When used in this
 8 article, the term "adjusted gross income" shall mean the following:

9 (a) In the case of all individuals, "adjusted gross income" (as defined

10 SECTION 62. [EFFECTIVE JANUARY 1, 2004 (RETROACTIVE)]
11 **(a) IC 6-2.5-3-5, as amended by this act, applies only to vehicles,**
12 **watercraft, and aircraft that are initially titled, registered, or**
13 **licensed in Indiana after June 30, 2004.**

14 **(b) IC 6-2.5-4-11, as amended by this act, applies only to**
15 **transactions occurring after March 1, 2004. A retail transaction to**
16 **which IC 6-2.5-4-11, as amended by this act, applies shall be**
17 **considered as having occurred after March 1, 2004, if charges are**
18 **collected for the retail transactions upon original statements and**
19 **billings dated after March 31, 2004.**

20 **(c) IC 6-2.5-8-10, as amended by this act, and the repeal of**
21 **IC 6-2.5-5-15 by this act apply only to retail transactions occurring**
22 **after June 30, 2004. A retail transaction shall be considered as**
23 **having occurred after June 30, 2004, to the extent that delivery of**

37 **31, 2003.**

38 **(f) The following provisions apply to deductions for net**
39 **operating losses that are claimed after December 31, 2003:**

40 **(1) Deductions for net operating losses that are incurred in**
41 **taxable years beginning after December 31, 2003, and are**
42 **carried back or carried forward and deducted in taxable years**

 4 **taxable years ending before January 1, 2004, and are carried**
 5 **back or carried forward and deducted in taxable years ending**
 6 **before January 1, 2004, must be calculated under the**
 7 **versions of IC 6-3-2-2.5 and IC 6-3-2-2.6 that were in effect**
 8 **in the year the net operating loss was incurred.**

9 **(4) Any net operating loss carried forward and deducted in a**
 10 **taxable year beginning after December 31, 2003, shall be**
 11 **reduced by the amount of the net operating loss previously**
 12 **deducted in an earlier taxable year.**

13 **(g) IC 6-4.1-1-3, as amended by this act, applies only to an**
 14 **adopting parent who dies after June 30, 2004.**

15 **SECTION 63. [EFFECTIVE UPON PASSAGE] (a) An individual**
 16 **who:**

17 **(1) was employed by Muscatatuck State Developmental**
 18 **Center on November 1, 2002;**

19 **(2) retired under the state's retirement incentive program**
 20 **that was effective beginning November 1, 2002, and ending**
 21 **June 14, 2003;**

22 **(3) would meet the years of service requirements specified in**
 23 **IC 5-10-8-8(b)(3) and the years of participation requirement**
 24 **specified in IC 5-10-8-8(b)(4) if:**

25 **(A) one (1) year of additional service credit is added to the**
 26 **individual's total years of service for every five (5) years**
 27 **of creditable state service; and**

28 **(B) pro rated months of additional service credit are added**
 29 **to the individual's total years of service for any additional**
 30 **years of creditable state service;**

31 **(4) otherwise meets the requirements of IC 5-10-8-8(b); and**

32 **(5) applies for participation in the group health insurance**
 33 **program under IC 5-10-8-8 before December 31, 2005;**

34 **is eligible for participation in the group health insurance program**
 35 **available to retired employees under IC 5-10-8-8.**

36 **(b) This SECTION expires December 31, 2006.**

37 **SECTION 64. [EFFECTIVE JULY 1, 2004] (a) As used in this**
 38 **SECTION, "committee" refers to the interim study committee on**
 39 **corporate taxation established under subsection (b).**

40 **(b) There is established the interim study committee on**
 41 **corporate taxation. The committee shall study the use of passive**
 42 **investment corporations by companies doing business in Indiana.**

43 **(c) The committee shall operate under the policies governing**
 44 **study committees adopted by the legislative council.**

45 **(d) The affirmative votes of a majority of the voting members**
 46 **appointed to the committee are required for the committee to**
 47 **take action on any measure, including final reports.**
