DIGEST OF INTRODUCED BILL

Citations Affected: None (noncode).

Synopsis: Medicaid waiver for family planning services. Requires the office of Medicaid policy and planning to apply for a demonstration waiver to extend Medicaid coverage of family planning services for certain women.

Effective: Upon passage.

SENATE BILL No. 62



A BILL FOR AN ACT concerning Medicaid.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. [EFFECTIVE UPON PASSAGE] (a) As used in this
- 2 SECTION, "family planning services" refers to family planning
- 3 services provided to Medicaid recipients under IC 12-15-5-1.
- 4 (b) As used in this SECTION, "office" refers to the office of
- 5 Medicaid policy and planning established by IC 12-8-6-1.
- 6 (c) As used in this SECTION, "waiver" refers to a Section 1115
- 7 demonstration waiver under the federal Social Security Act (42
- 8 U.S.C. 1315).
- 9 (d) Before January 1, 2005, the office shall apply to the United
- 10 States Department of Health and Human Services for approval of
- 11 a waiver to:
- 12 (1) continue coverage of family planning services for a woman
- 13 described in IC 12-15-2-13 for two (2) years after the
- 14 expiration of the postpartum eligibility period under
- 15 IC 12-15-2-13(d); and
- 16 (2) provide Medicaid coverage for any other service required
- 17 by the waiver.
- 18 (e) If a provision of this SECTION differs from the



1 requirements of a waiver, the office shall submit the waiver request
 2 in a manner that complies with the requirements of the waiver.
 3 However, if the waiver is approved, the office, not more than one
 4 hundred twenty (120) days after the waiver is approved, shall
 5 apply for an amendment to the waiver that contains the provisions
 6 of this SECTION that were not included in the approved waiver.
 7 (f) The office may not implement the waiver until the office files
 8 an affidavit with the governor attesting that the federal waiver
 9 applied for under this SECTION is in effect. The office shall file the
 10 affidavit under this subsection not more than five (5) days after the
 11 office is notified that the waiver is approved.
 12 (g) If the office receives a waiver under this SECTION from the
 13 United States Department of Health and Human Services and the
 14 governor receives the affidavit filed under subsection (f), the office
 15 shall implement the waiver not more than sixty (60) days after the
 16 governor receives the affidavit.
 17 (h) The office may adopt rules under IC 4-22-2 that are
 18 necessary to implement this SECTION.
 19 (i) This SECTION expires January 1, 2010.
 20 SECTION 2. An emergency is declared for this act.
