## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 25-1-12.

**Synopsis:** License extension for military service. Establishes an extension of time to: (1) renew a professional or an occupational license, certificate, registration, or permit; and (2) complete continuing education requirements; for an individual called to active duty in the armed forces of the United States or the Indiana army or air national guard.

**Effective:** Upon passage.

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 25-1-12 IS ADDED TO THE INDIANA CODE AS  
2 A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE UPON  
3 PASSAGE]:  
4 **Chapter 12. Renewal of Licenses Held by Individuals in Military**  
5 **Service**  
6 **Sec. 1. This chapter applies to an individual who:**  
7 (1) holds a license, certificate, registration, or permit under  
8 this title, IC 15, IC 16, or IC 22; and  
9 (2) is called to active duty.  
10 **Sec. 2. As used in this chapter, "active duty" means full-time**  
11 **service in the:**  
12 (1) armed forces of the United States; or  
13 (2) national guard;  
14 **for a period that exceeds thirty (30) consecutive days in a calendar**  
15 **year.**  
16 **Sec. 3. As used in this chapter, "armed forces of the United**  
17 **States" means the active or reserve components of:**



- 1           (1) the army;
- 2           (2) the navy;
- 3           (3) the air force;
- 4           (4) the coast guard;
- 5           (5) the marine corp; or
- 6           (6) the merchant marine.
- 7           **Sec. 4. As used in this chapter, "national guard" means:**
- 8           (1) the Indiana army national guard; or
- 9           (2) the Indiana air national guard.
- 10          **Sec. 5. As used in this chapter, "practitioner" means an**
- 11 **individual who holds:**
- 12          (1) an unlimited license, certificate, or registration;
- 13          (2) a limited or probationary license, certificate, or
- 14          registration;
- 15          (3) a temporary license, certificate, registration, or permit;
- 16          (4) an intern permit; or
- 17          (5) a provisional license;
- 18          **issued under this title or IC 15, IC 16, or IC 22.**
- 19          **Sec. 6. (a) Notwithstanding any other law, a practitioner who is**
- 20 **called to active duty out-of-state and meets the requirements of**
- 21 **subsection (b) is entitled to an extension of time described in**
- 22 **subsection (c) to:**
- 23          (1) renew; and
- 24          (2) complete the continuing education required by;
- 25          **the practitioner's license, certificate, registration, or permit.**
- 26          **(b) The practitioner must meet the following requirements to**
- 27 **receive the extension of time provided under subsection (a):**
- 28          (1) **On the date the practitioner enters active duty, the**
- 29 **practitioner's license, certificate, registration, or permit may**
- 30 **not be revoked, suspended, lapsed, or be the subject of a**
- 31 **complaint under IC 25-1-7.**
- 32          (2) **While the practitioner is out-of-state on active duty:**
- 33                (A) **the practitioner's license, certificate, registration, or**
- 34                **permit must expire; and**
- 35                (B) **the practitioner must not have received the notice of**
- 36                **expiration before the date the practitioner entered active**
- 37                **duty.**
- 38          (3) **The practitioner shall provide proof of out-of-state active**
- 39 **duty by providing a copy of the practitioner's:**
- 40                (A) **discharge; or**
- 41                (B) **government movement orders;**
- 42          **to the agency issuing the practitioner's license, certificate,**

1 registration, or permit at the time the practitioner renews the  
 2 practitioner's license, certificate, registration, or permit under  
 3 this chapter.  
 4 (c) The extension of time provided under subsection (a) is equal  
 5 to one hundred eighty (180) days after the date of the practitioner's  
 6 discharge or release from active duty.  
 7 (d) The agency or board that issued the practitioner's license,  
 8 certificate, registration, or permit may extend the period provided  
 9 in subsection (c) if the agency or board determines that an illness,  
 10 an injury, or a disability related to the practitioner's active duty  
 11 prevents the practitioner from renewing or completing the  
 12 continuing education required for the practitioner's license,  
 13 certificate, registration, or permit. However, the agency may not  
 14 extend the period for longer than three hundred sixty-five (365)  
 15 days after the date of the practitioner's discharge or release from  
 16 active duty.  
 17 **Sec. 7. Any late fees that may be assessed against a practitioner**  
 18 **in connection with a renewal under this chapter are waived.**  
 19 **Sec. 8. This chapter may not be construed as a restriction or**  
 20 **limitation on any of the rights, benefits, and protections granted to**  
 21 **a member of:**  
 22 (1) the armed forces of the United States; or  
 23 (2) the national guard;  
 24 **under federal law.**  
 25 **SECTION 2. [EFFECTIVE UPON PASSAGE] IC 25-1-12, as**  
 26 **added by this act, applies to all individuals who:**  
 27 (1) hold a license, certificate, registration, or permit under  
 28 IC 15, IC 16, IC 22, or IC 25; and  
 29 (2) have been called to full-time service in the:  
 30 (A) armed forces of the United States (as defined in  
 31 IC 25-1-12-3, as added by this act); or  
 32 (B) Indiana army or air national guard;  
 33 **after September 11, 2001.**  
 34 **SECTION 3. An emergency is declared for this act.**
