

SENATE MOTION

MADAM PRESIDENT:

I move that Engrossed House Bill 1301 be amended to read as follows:

- 1 Page 2, between lines 41 and 42 , begin a new paragraph and insert:
2 "SECTION 4. IC 9-18-25-17.5 IS ADDED TO THE INDIANA
3 CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE
4 JULY 1, 2004]: **Sec. 17.5. (a) This section applies to a special group
5 if at least five thousand (5,000) of the special group's license
6 plates are issued under this chapter during one (1) calendar year
7 beginning after December 31, 2004.**
8 **(b) Notwithstanding section 3 of this chapter, the
9 representatives of the special group may petition the bureau to
10 design a distinctive license plate that identifies a vehicle as being
11 registered to a person who is a member of the special group.**
12 **(c) The design of the special group license plate must include
13 a basic design for the special group recognition license plate with
14 consecutive numerals or letters, or both, to properly identify the
15 vehicle.**
16 **(d) A special group license plate must be treated with special
17 reflective material designed to increase the visibility and legibility
18 of the special group license plate.**
19 **(e) Beginning with the calendar year following the year in
20 which the representatives petition the bureau under subsection
21 (b), the bureau shall issue the special group's license plate to a
22 person who is eligible to register a vehicle under this title who:
23 (1) completes an application for the license plate; and
24 (2) pays the following fees:
25 (A) The appropriate fee under IC 9-29-5-38(a).
26 (B) An annual fee of twenty-five dollars (\$25).
27 **(f) The annual fee referred to in subsection (e)(2)(B) shall be
28 collected by the bureau and deposited in a trust fund for the
29 special group established under subsection (g). However, the****

1 **bureau shall retain two dollars (\$2) for each license plate issued**
2 **until the cost of designing and issuing the special group license**
3 **plate is recovered by the bureau.**

4 **(g) The treasurer of state shall establish a trust fund for each**
5 **special group for which the bureau collects fees under this section.**

6 **(h) The treasurer of state shall invest the money in the fund**
7 **not currently needed to meet the obligations of the fund in the**
8 **same manner as other public funds are invested. Interest that**
9 **accrues from these investments shall be deposited in the fund.**
10 **Money in the fund is continuously appropriated for the purposes**
11 **of this section. Money in the fund at the end of a state fiscal year**
12 **does not revert to the state general fund.**

13 **(i) The commissioner shall administer the fund. Expenses of**
14 **administering the fund shall be paid from money in the fund.**

15 **(j) On June 30 of each year, the commissioner shall distribute**
16 **the money from the fund to the special group for which the**
17 **bureau has collected fees under this section.**

18 **(k) The bureau may not disclose information that identifies the**
19 **persons to whom special group license plates have been issued**
20 **under this section to the special group."**
