DIGEST OF SB 37 (Updated January 26, 2004 12:13 pm - DI 102)

Citations Affected: IC 3-10.

Synopsis: Retention of election materials. Makes available to the public election material required to be retained following an election after expiration of the period for filing a petition or cross-petition for a recount of votes or to contest the election. Requires a county voter registration office to keep confidential that part of election material necessary to protect the secrecy of a voter's ballot.

Effective: Upon passage.

SENATE BILL No. 37



A BILL FOR AN ACT to amend the Indiana Code concerning elections.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 3-10-1-31, AS AMENDED BY P.L.209-2003,
2 SECTION 101, IS AMENDED TO READ AS FOLLOWS
3 [EFFECTIVE UPON PASSAGE]: Sec. 31. (a) The inspector of each
4 precinct shall deliver the bags required by section 30(a) and 30(c) of
5 this chapter in good condition, together with poll lists, tally sheets, and
6 other forms, to the circuit court clerk when making returns.

7 (b) Except for unused ballots disposed of under IC 3-11-3-31 **or**
8 **affidavits received by the county election board under IC 3-14-5-2**
9 **for delivery to the foreman of a grand jury**, the circuit court clerk
10 shall ~~carefully preserve seal~~ the ballots and other material ~~and keep all~~
11 ~~seals intact during the time allowed to file a verified petition or~~
12 **cross-petition for a recount of votes or to contest the election.**
13 **Except as provided in subsection (c), after the recount or contest**
14 **filing period, the election material (except for ballots, which**
15 **remain confidential) shall be made available for copying and**
16 **inspection under IC 5-14-3. The circuit court clerk shall carefully**
17 **preserve the sealed ballots and other material for twenty-two (22)**

16 **or (c)**, the ballots may be destroyed in the manner provided by
17 IC 3-11-3-31 or transferred to a state educational institution as
