DIGEST OF SB 155 (Updated January 15, 2004 12:54 pm - DI 44)

Citations Affected: IC 36-3.

Synopsis: Budget and levy review in Marion County. Requires the city-county council in Marion County to review the proposed operating and maintenance budgets and tax levies of certain entities and to adopt final operating and maintenance budgets and tax levies for those entities. Authorizes the city-county council to reduce or modify but not increase an entity's proposed operating and maintenance budget or tax levy.

Effective: July 1, 2004.

A BILL FOR AN ACT to amend the Indiana Code concerning taxation.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 36-3-6-9 IS AMENDED TO READ AS FOLLOWS
2 [EFFECTIVE JULY 1, 2004]: Sec. 9. (a) The city-county legislative

16 (b) The board of each entity listed in subsection (a) shall, after
17 adoption of its **proposed** budget and tax levies, submit them, along

1 with detailed accounts, to the city clerk before the first day of
2 September of each year.

3 (c) The city-county legislative body may review the issuance of
4 bonds of an entity listed in subsection (a), but approval of the
5 city-county legislative body is not required for the issuance of bonds.
