**Citations Affected:** IC 16-19.

**Synopsis:** Safety of children during storms. Requires the state department of health to adopt guidelines concerning the safety of children during bad weather conditions and to distribute the guidelines to the department of education and make the guidelines available to certain persons.

**Effective:** July 1, 2005.

## ENGROSSED SENATE BILL No. 569

A BILL FOR AN ACT to amend the Indiana Code concerning health.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 16-19-3-6.5 IS ADDED TO THE INDIANA CODE  
2 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2005]: **Sec. 6.5. (a) The state department shall adopt guidelines  
4 concerning the safety of children during bad weather conditions.**  
5 **(b) The guidelines adopted under subsection (a) must include a  
6 listing of places that are safe during the following types of weather  
7 conditions:**  
8 **(A) Blizzards.**  
9 **(B) Tornados.**  
10 **(C) Rain storms.**  
11 **(D) Lightning storms.**  
12 **(E) Hail storms.**  
13 **(F) Wind storms.**  
14 **(G) Extreme heat.**  
15 **(H) Any other weather condition for which the National  
16 Weather Service issues an advisory, a watch, or a warning.**
