MR. SPEAKER:

I move that Engrossed Senate Bill 459 be amended to read as follows:

- 1 Page 1, between lines 14 and 15, begin a new paragraph and insert:
- 2 "SECTION 2. IC 6-3-3-11 IS ADDED TO THE INDIANA CODE
- 3 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE
- 4 JANUARY 1, 2006]: **Sec. 11. (a) As used in this section, "eligible**
- 5 **physician" means a physician:**
- 6 **(1) who is licensed under IC 25-22.5; and**
- 7 **(2) whose eligibility for the tax credit allowed under this**
- 8 **section is certified by the office.**
- 9 **(b) As used in this section, "office" refers to the office of**
- 10 **Medicaid policy and planning established by IC 12-8-6-1.**
- 11 **(c) A physician may submit a statement, at the times and in the**
- 12 **form prescribed by the office, requesting a certification of the**
- 13 **physician's eligibility for the tax credit allowed under this section.**
- 14 **(d) The office shall certify that a physician is eligible for the tax**
- 15 **credit allowed under this section and issue a certificate of eligibility**
- 16 **to the physician if the physician serves as a primary medical**
- 17 **provider:**
- 18 **(1) under the Medicaid program under IC 12-15; and**
- 19 **(2) to at least five hundred (500) Medicaid recipients during**
- 20 **the physician's taxable year.**
- 21 **(e) An eligible physician is entitled to a credit against the**
- 22 **physician's adjusted gross income tax liability equal to five**
- 23 **hundred dollars (\$500) for each taxable year that the physician's**
- 24 **eligibility for the tax credit is certified by the office.**
- 25 **(f) To receive the credit allowed under this section, an eligible**

1 **physician must claim the credit on the physician's annual state tax**
2 **return or returns in the manner prescribed by the department. The**
3 **physician shall submit to the department a copy of the physician's**
4 **certificate of eligibility for the tax credit.**

5 **(g) The credit allowed by this section may not exceed the amount**
6 **of the physician's adjusted gross income tax imposed by IC 6-3-1**
7 **through IC 6-3-7 for the taxable year, reduced by the sum of all**
8 **credits (as determined without regard to this section) allowed by**
9 **IC 6-3-1 through IC 6-3-7."**

10 Page 6, between lines 35 and 36, begin a new paragraph and insert:
11 "SECTION 8. [EFFECTIVE JANUARY 1, 2006] **IC 6-3-3-11, as**
12 **added by this act, applies to taxable years beginning after**
13 **December 31, 2005."**

14 Renumber all SECTIONS consecutively.
