MR. SPEAKER:

I move that House Bill 1003 be amended to read as follows:

- 1 Page 37, between lines 20 and 21, begin a new paragraph and insert:
- 2 "Sec. 8. (a) The definitions in IC 3-5-2 apply to this section to the
- 3 extent they do not conflict with the definitions in this article.
- 4 (b) This section applies to the following:
- 5 (1) An individual or entity that receives a grant, a loan, a tax
- 6 credit, or another benefit from the corporation or an entity
- 7 owned or administered by the corporation.
- 8 (2) An officer or board member of an entity described in
- 9 subdivision (1).
- 10 (3) A political action committee of an entity described in
- 11 subdivision (1).
- 12 (4) A registered lobbyist who receives compensation from an
- 13 individual or entity described in subdivision (1), (2), or (3).
- 14 (c) An individual or entity described in subsection (b) may not
- 15 make a contribution to any of the following:
- 16 (1) An individual appointed to:
- 17 (A) the board; or
- 18 (B) the advisory committee under IC 5-28-5-6.
- 19 (2) A candidate's committee for an individual described in
- 20 subdivision (1).
- 21 (d) An individual or entity described in subsection (b) may not
- 22 make a contribution to any of the following during the two (2)
- 23 years after the individual or entity receives a grant, a loan, a tax
- 24 credit, or another benefit from the corporation or an entity owned
- 25 or administered by the corporation:

- 1 **(1) A state party committee.**
- 2 **(2) A committee organized by a legislative caucus of the**
- 3 **general assembly.**
- 4 **(e) An individual appointed to the board or the advisory**
- 5 **committee under IC 5-28-5-6, or a candidate's committee for the**
- 6 **individual, may not solicit or accept a contribution from an**
- 7 **individual or entity described in subsection (b):**
- 8 **(1) while the individual is a member of the board or advisory**
- 9 **committee; or**
- 10 **(2) during the two (2) years after the individual ceases to serve**
- 11 **on the board or advisory committee.**
- 12 **(f) A person who knowingly or intentionally violates this section**
- 13 **commits a Class D felony."**
- 14 Page 193, between lines 1 and 2, begin a new paragraph and insert:
- 15 "**SECTION 135. [EFFECTIVE UPON PASSAGE] IC 5-28-4-8, as**
- 16 **added by this act, applies only to contributions made after the**
- 17 **effective date of this act."**
- 18 Renumber all SECTIONS consecutively.
