MR. SPEAKER:

I move that House Bill 1003 be amended to read as follows:

- 1 Page 37, line 39, after "5." insert "(a)".
- 2 Page 38, line 4, after "ethics commission." delete "commission."
- 3 Page 38, between lines 4 and 5, begin a new paragraph and insert:
- 4 **"(b) Notwithstanding any other provision, the board shall adopt**
- 5 **ethics rules under IC 4-22-2 establishing standards governing the**
- 6 **solicitation and acceptance by the board, the corporation, an entity**
- 7 **owned or administered by the corporation, or an employee of the**
- 8 **corporation or an entity owned or administered by the corporation**
- 9 **of gifts and donations that:**
- 10 **(1) will be used by the board, the corporation, the state, or an**
- 11 **entity owned or administered by the corporation; and**
- 12 **(2) are made by an individual or entity that has applied for or**
- 13 **received a grant, a loan, a tax credit, or another benefit from**
- 14 **the corporation or an entity owned or administered by the**
- 15 **corporation.**
- 16 **(c) The rules adopted under subsection (b) must include at least**
- 17 **the following provisions:**
- 18 **(1) The rules must prohibit the board, the corporation, an**
- 19 **entity owned or administered by the corporation, or an**
- 20 **employee of the corporation or an entity owned or**
- 21 **administered by the corporation from awarding a grant, a**
- 22 **loan, a tax credit, or another benefit to an individual or entity**
- 23 **that, during the preceding one (1) year, made a gift or**
- 24 **donation that will be used by the board, the corporation, the**
- 25 **state, or an entity owned or administered by the corporation.**

1 **(2) The rules must prohibit the board, the corporation, an**
 2 **entity owned or administered by the corporation, or an**
 3 **employee of the corporation or an entity owned or**
 4 **administered by the corporation from soliciting or accepting**
 5 **a gift or donation from an individual or entity that, during the**
 6 **preceding one (1) year, received a grant, a loan, a tax credit,**
 7 **or another benefit from the corporation or an entity owned or**
 8 **administered by the corporation.**

9 **(d) The corporation must include on the corporation's Internet**
 10 **web site a prominently displayed link or connection to a list of the**
 11 **recipients of a grant, a loan, a tax credit, or another benefit from**
 12 **the corporation or an entity owned or administered by the**
 13 **corporation. The list:**

14 **(1) must include:**
 15 **(A) the type and dollar amount of the grant, loan, tax**
 16 **credit, or other benefit received by the recipient; and**
 17 **(B) the dollar amount of any contributions made by the**
 18 **recipient to the corporation or an entity owned or**
 19 **administered by the corporation; and**
 20 **(2) must be updated at least monthly."**

21 Page 193, between lines 1 and 2, begin a new paragraph and insert:
 22 "SECTION 135. [EFFECTIVE UPON PASSAGE] **(a) The board**
 23 **of the Indiana economic development corporation shall adopt**
 24 **emergency rules under IC 4-22-2-37.1 to implement the ethics rules**
 25 **required under IC 5-28-5-5, as added by this act. A rule adopted**
 26 **under this SECTION must be adopted not later than twenty-one**
 27 **(21) days after the effective date of this act. An emergency rule**
 28 **adopted under this SECTION expires on the date a rule is adopted**
 29 **by the board of the Indiana economic development corporation**
 30 **under IC 4-22-2-24 through IC 4-22-2-36 to implement ethics rules**
 31 **required under IC 5-28-5-5, as added by this act.**

32 **(b) This SECTION expires July 1, 2007."**

33 Renumber all SECTIONS consecutively.
