I move that House Bill 1845 be amended to read as follows:

- 4           December 31, 2006." and insert "**2005. Notwithstanding the general**
- 5           **rule of this subsection, the budget agency shall compute the first**
- 6           **estimate required under this subsection not later than April 1,**
- 7           **2005."**
- 8           Page 3, line 21, delete "2007," and insert "**2005,"**.
- 9           Page 3, line 22, delete "2007." and insert "**2005."**
- 10          Page 8, line 33, delete ":".
- 11          Page 8, line 34, delete "(1) for state fiscal years ending before July
- 12          1, 2007,".
- 13          Page 8, line 34, strike "state".
- 14          Page 8, line 35, strike "spending cap determined under section 2 of
- 15          this".
- 16          Page 8, line 35, delete "chapter; and" and insert "~~chapter~~".
- 17          Page 8, delete line 36.
- 18          Page 8, run in lines 33 through 37.
- 19          Page 8, delete lines 39 through 42.
- 20          Delete page 9.
- 21          Page 10, delete lines 1 through 28.
- 22          Page 10, line 31, delete "After June 30, 2007, the" and insert "**The**".
- 23          Page 11, delete lines 2 through 42.

- 25          Page 13, line 20, delete "IC 4-10-21-3; IC 4-10-21-4." and insert

3 Page 13, after line 20, begin a new paragraph and insert:  
4 "SECTION 12. [EFFECTIVE UPON PASSAGE] **Notwithstanding**  
5 **IC 2-2.1-4-8(a), as added by this act, the budget agency shall submit**  
6 **to the executive director of the legislative services agency not later**  
7 **than April 3, 2005, the report described under IC 2-2.1-4-8(a), as**  
8 **added by this act, in an electronic format under IC 5-14-6.**  
9 SECTION 13. **An emergency is declared for this act.**  
10 Renumber all SECTIONS consecutively.
