## HOUSE BILL No. 1105

---

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 9-18-19-1 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JULY 1, 2005]: Sec. 1. The bureau shall  
3 design and issue a passenger vehicle license plate that will designate  
4 the vehicle as being registered to:

5 (1) a person; **or**

6 (2) **the surviving spouse of a person;**

7 who has received a Purple Heart decoration that is awarded to a person  
8 who suffers an injury while serving as a member of the armed forces of  
9 the United States.

10 SECTION 2. IC 9-18-19-2 IS AMENDED TO READ AS  
11 FOLLOWS [EFFECTIVE JULY 1, 2005]: Sec. 2. A resident of Indiana  
12 who is:

13 (1) a recipient of a Purple Heart decoration; **or**

14 (2) **the surviving spouse of a person described in subdivision**

15 (1);

16 may apply for and receive one (1) or more Purple Heart plates.
