## COMMITTEE REPORT

**MR. SPEAKER:**

*Your Committee on Natural Resources, to which was referred Senate Bill 554, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1            Page 4, between lines 19 and 20, begin a new paragraph and insert:
- 2            "SECTION 10. IC 14-22-11-8 IS AMENDED TO READ AS
- 3            FOLLOWS [EFFECTIVE JULY 1, 2005]: Sec. 8. (a) This section does
- 4            not apply to the following:
- 5            ~~(1)~~ A person who is:
- 6                   ~~(A)~~ a resident of Indiana; and
- 7                   ~~(B)~~ at least sixty-five ~~(65)~~ years of age;
- 8            ~~(2)~~ **(1)** A person who is less than seventeen (17) years of age.
- 9            ~~(3)~~ **(2)** A person who is legally blind.
- 10          ~~(4)~~ **(3)** A person who is a resident patient of a state mental
- 11          institution.
- 12          ~~(5)~~ **(4)** A person who is:
- 13                 (A) a resident of a health facility (as defined in
- 14                 IC 16-18-2-167) licensed in Indiana; and
- 15                 (B) taking part in a supervised activity of the health facility.

- 1           ~~(5)~~ (5) A person who:
- 2                   (A) is a resident of Indiana; and
- 3                   (B) has a developmental disability (as defined by
- 4                   IC 12-7-2-61).
- 5           ~~(6)~~ (6) A person whose only participation in fishing is to assist an
- 6           individual described in subdivision (2), (3), (4), or (5). ~~or (6):~~
- 7           ~~(7)~~ (7) A resident of Indiana who fishes during a free sport fishing
- 8           day designated under IC 14-22-18.
- 9           (b) Every person must have a fishing license in the person's
- 10          possession when fishing in:
- 11                   (1) waters containing state owned fish;
- 12                   (2) waters of the state; or
- 13                   (3) boundary waters of the state.
- 14          (c) Every person must have a valid trout-salmon stamp in the
- 15          person's possession to legally fish for or take trout or salmon in:
- 16                   (1) waters containing state owned fish;
- 17                   (2) waters of the state; or
- 18                   (3) boundary waters of the state.
- 19          SECTION 11. IC 14-22-12-1 IS AMENDED TO READ AS
- 20          FOLLOWS [EFFECTIVE JULY 1, 2005]: Sec. 1. (a) The department
- 21          may issue the following licenses and, except as provided in section 1.5
- 22          of this chapter and subject to subsection (b), shall charge the following
- 23          minimum license fees to hunt, trap, or fish in Indiana:
- 24                   (1) A resident yearly license to fish, eight dollars and seventy-five
- 25                   cents (\$8.75).
- 26                   (2) A resident yearly license to hunt, eight dollars and
- 27                   seventy-five cents (\$8.75).
- 28                   (3) A resident yearly license to hunt and fish, thirteen dollars and
- 29                   seventy-five cents (\$13.75).
- 30                   (4) A resident yearly license to trap, eight dollars and seventy-five
- 31                   cents (\$8.75).
- 32                   (5) A nonresident yearly license to fish, twenty-four dollars and
- 33                   seventy-five cents (\$24.75).
- 34                   (6) A nonresident yearly license to hunt, sixty dollars and
- 35                   seventy-five cents (\$60.75).
- 36                   (7) A nonresident yearly license to trap, one hundred seventeen
- 37                   dollars and seventy-five cents (\$117.75). However, a license may
- 38                   not be issued to a resident of another state if that state does not

- 1 give reciprocity rights to Indiana residents similar to those  
2 nonresident trapping privileges extended in Indiana.
- 3 (8) A resident or nonresident license to fish, including for trout  
4 and salmon, for one (1) day only, four dollars and seventy-five  
5 cents (\$4.75).
- 6 (9) A nonresident license to fish, excluding for trout and salmon,  
7 for seven (7) days only, twelve dollars and seventy-five cents  
8 (\$12.75).
- 9 (10) A nonresident license to hunt for five (5) consecutive days  
10 only, twenty-five dollars and seventy-five cents (\$25.75).
- 11 (11) A resident or nonresident yearly stamp to fish for trout and  
12 salmon, six dollars and seventy-five cents (\$6.75).
- 13 (12) A resident yearly license to take a deer with a shotgun,  
14 muzzle loading gun, or handgun, thirteen dollars and seventy-five  
15 cents (\$13.75).
- 16 (13) A resident yearly license to take a deer with a muzzle loading  
17 gun, thirteen dollars and seventy-five cents (\$13.75).
- 18 (14) A resident yearly license to take a deer with a bow and  
19 arrow, thirteen dollars and seventy-five cents (\$13.75).
- 20 (15) A nonresident yearly license to take a deer with a shotgun,  
21 muzzle loading gun, or handgun, one hundred twenty dollars and  
22 seventy-five cents (\$120.75).
- 23 (16) A nonresident yearly license to take a deer with a muzzle  
24 loading gun, one hundred twenty dollars and seventy-five cents  
25 (\$120.75).
- 26 (17) A nonresident yearly license to take a deer with a bow and  
27 arrow, one hundred twenty dollars and seventy-five cents  
28 (\$120.75).
- 29 (18) A resident license to take an extra deer by a means, in a  
30 location, and under conditions established by rule adopted by the  
31 department under IC 4-22-2, thirteen dollars and seventy-five  
32 cents (\$13.75).
- 33 (19) A nonresident license to take an extra deer by a means, in a  
34 location, and under conditions established by rule adopted by the  
35 department under IC 4-22-2, one hundred twenty dollars and  
36 seventy-five cents (\$120.75).
- 37 (20) A resident yearly license to take a turkey, fourteen dollars  
38 and seventy-five cents (\$14.75).

- 1 (21) A nonresident yearly license to take a turkey, one hundred  
2 fourteen dollars and seventy-five cents (\$114.75). However, if the  
3 state of residence of the nonresident applicant requires that before  
4 a resident of Indiana may take turkey in that state the resident of  
5 Indiana must also purchase another license in addition to a  
6 nonresident license to take turkey, the applicant must also  
7 purchase a nonresident yearly license to hunt under this section.
- 8 (22) If a fall wild turkey season is established, a resident license  
9 to take an extra turkey by a means, in a location, and under  
10 conditions established by rule adopted by the department under  
11 IC 4-22-2, fourteen dollars and seventy-five cents (\$14.75).
- 12 (23) If a fall wild turkey season is established, a nonresident  
13 license to take an extra turkey by a means, in a location, and under  
14 conditions established by rule adopted by the department under  
15 IC 4-22-2, one hundred fourteen dollars and seventy-five cents  
16 (\$114.75). However, if the state of residence of the nonresident  
17 applicant requires that before a resident of Indiana may take  
18 turkey in that state the resident of Indiana must also purchase  
19 another license in addition to a nonresident license to take turkey,  
20 the applicant must also purchase a nonresident yearly license to  
21 hunt under this section.
- 22 (24) A resident youth yearly consolidated license to hunt and fish,  
23 six dollars (\$6). This license is subject to the following:
- 24 (A) An applicant must be less than eighteen (18) years of age.  
25 (B) The license is in lieu of the resident yearly license to hunt  
26 and fish and all other yearly licenses, stamps, or permits to  
27 hunt and fish for a specific species or by a specific means.
- 28 **(25) A resident senior yearly license to fish, three dollars (\$3).**  
29 **This license is subject to the following:**
- 30 **(A) An applicant must be at least sixty (60) years of age.**  
31 **(B) The license is in place of the resident yearly license to**  
32 **fish and all other yearly licenses, stamps, or permits to fish**  
33 **for a specific species or by a specific means.**

- 1 (b) The commission may set license fees to hunt, trap, or fish above
- 2 the minimum fees established under subsection (a).".
- 3 Renumber all SECTIONS consecutively.  
(Reference is to SB 554 as printed February 1, 2005.)
