- 3            Page 2, between lines 6 and 7, begin a new line block indented and
- 4            insert:
- 5            "**(5) The chairman of the state fair advisory committee**
- 6            **appointed under IC 15-1-1.5-5(c) or a member of the**
- 7            **committee designated by the chairman may serve as an ex**
- 8            **officio nonvoting member.**".
- 9            Page 5, line 10, delete "following:" and insert "following, **with**
- 10           **approval by the commission:**".
- 11           Page 5, line 12, delete ", with approval by the commission." and
- 12           insert ".".
- 13           Page 5, line 17, after "Purchase" insert ",".
- 14           Page 5, line 17, reset in roman "lease,".
- 15           Page 6, between lines 28 and 29, begin a new paragraph and insert:
- 16           "**(d) Notwithstanding IC 4-2-6-5, with approval by the**

- 2               **(1) may be compensated in full or in part by the nonprofit**
- 3               **entity established under section 10 of this chapter; and**
- 4               **(2) may perform services that support the purposes of the**

- 11      Page 7, strike lines 10 through 13.
- 12      Page 7, reset in roman line 14.
- 13      Page 7, line 15, reset in roman "proceeds from the operations of
- 14      the".
- 15      Page 7, line 15, delete "barn." and insert "**barn, subject to approval**
- 16      **by the commission."**
- 17      Page 7, line 16, reset in roman "(c)".
- 18      Page 7, line 16, delete "(b)".
- 19      Page 7, line 28, delete "appropriated" and insert "**allocated by the**
- 20      **commission"**.
