

# SENATE MOTION

**MADAM PRESIDENT:**

**I move** that Senate Bill 38 be amended to read as follows:

- 1 Page 2, delete lines 10 through 13.
- 2 Page 2, line 14, delete "(2)" and insert "**(1)**".
- 3 Page 2, line 18, delete "(3)" and insert "**(2)**".
- 4 Page 2, line 24, after "5." insert "**(a)**".
- 5 Page 2, line 24, after "provided in" insert "**subsection (b) and**".
- 6 Page 2, line 27, after "service" insert "**fee,**".
- 7 Page 2, line 27, delete "or".
- 8 Page 2, line 27, delete "fee." and insert "**fee, dormancy charge,**
- 9 **or inactivity charge.**".
- 10 Page 2, delete line 28, begin a new paragraph and insert:
- 11 "**(b) A gift certificate may be subject to an initial fee at the time**
- 12 **the gift certificate is issued.**".
- 13 Page 2, line 31, delete "The language "Expires: (insert date)."" and
- 14 insert "**One (1) of the following**".
- 15 Page 2, line 32, delete "10" and insert "**8**".
- 16 Page 2, line 33, delete "certificate." and insert "**certificate:**
- 17 **(A) The date or time period after which the gift**
- 18 **certificate expires.**
- 19 **(B) The exact date on which the gift certificate was**
- 20 **issued and the number of days following the date of**
- 21 **issuance after which the gift certificate expires.**".
- 22 Page 2, line 36, delete "dormancy or".
- 23 Page 2, line 37, delete "inactivity charge" and insert "**fee**".
- 24 Page 2, delete lines 38 through 42, begin a new line block indented
- 25 and insert:
- 26 "**(1) The fee does not begin to accrue until at least six (6)**
- 27 **months after the date on which the gift certificate was issued.**
- 28 **(2) A statement printed on the gift certificate or on a sticker**
- 29 **permanently affixed to the gift certificate in at least 8 point**
- 30 **type states:**
- 31 **(A) the type of fee and the dollar amount of the fee; and**
- 32 **(B) one (1) of the following:**

- 1                   **(i) The date or time period after which the fee**  
2                   **begins to accrue.**  
3                   **(ii) The exact date on which the gift certificate was**  
4                   **issued and the number of days following the date of**  
5                   **issuance after which the fee begins to accrue."**

6                   Page 3, delete lines 1 through 12.

7                   Page 3, line 13, delete "9." and insert "8."
