- 3 Page 1, line 7, reset in roman "(a)".
- 4 Page 1, line 7, delete "(b)".
- 5 Page 1, line 7, strike "may," and insert "**shall**".
- 6 Page 1, run in lines 2 through 7.
- 7 Page 1, line 9, strike "equal to one and one-half percent (1.5%) per
- 8 month" and insert "**that are at least the equivalent of the interest rate**
- 9 **for a final judgment (as defined in IC 34-54-8-5) on the date a child**
- 10 **support order is issued**".
- 11 Page 1, line 11, delete "(c)" and insert "**(b)**".
- 12 Page 1, line 12, after "modified;" strike "or".
- 13 Page 1, line 14, after "order" delete "." and insert "; **or**
- 14 **(3) at any time for a child support order that has been**
- 15 **issued**".
- 16 Page 1, line 15, delete "(d)" and insert "(c)".
- 17 Page 2, line 1, delete "(a) A court shall".
- 18 Page 2, delete lines 2 through 5.
- 19 Page 2, line 6, delete "(b)" and insert "**(a)**".
- 20 Page 2, line 6, strike "may," and insert "**shall**".

- 1 Page 2, run in lines 1 through 6.
- 2 Page 2, line 7, strike "of not more".
- 3 Page 2, line 8, strike "than one and one-half percent (1 1/2%) per
- 4 month" and insert "**that are at least the equivalent of the interest rate**
- 5 **for a final judgment (as defined in IC 34-54-8-5) on the date a child**
- 6 **support order is issued**".
- 7 Page 2, line 9, delete "." and insert "**that occurs**".
- 8 Page 2, line 10, delete "(c)" and insert "**(b)**".
- 9 Page 2, line 14, delete "(a) Interest charges".
- 10 Page 2, delete lines 15 through 26.
- 11 Page 2, line 27, delete "(c)" and insert "**(a)**".
- 12 Page 2, run in lines 14 through 27.
- 13 Page 2, line 29, delete "under subsection (a)".
- 14 Page 2, line 30, delete "(d)" and insert "**(b)**".
