DIGEST OF HB 1101 (Updated March 2, 2006 3:29 pm - DI 106)

Synopsis: Security breach disclosure and identity deception. Provides that a person that owns or licenses certain unredacted or unencrypted personal information concerning Indiana residents that is contained in a computerized data base must disclose to those Indiana residents without unreasonable delay a security breach in the computerized data base (including the unauthorized acquisition of computerized data that have been transferred to another medium) if the security breach could cause the Indiana residents to become victims of identity theft, identity deception, or fraud. Requires a database owner who is required to make a disclosure concerning a security breach to more than 1,000 persons (Continued next page)

to notify each credit reporting bureau of the security breach. Specifies that a person that maintains a computer data base but does not own or license the personal information contained in the data base must notify the data base owner if there is a security breach in the data base. Provides that a data base owner with a privacy plan drafted to comply with certain federal statutes may comply with that plan instead of these provisions if that plan meets the federal requirements, and permits a data base owner with its own privacy plan to comply with its own plan instead of these provisions if its plan is at least as stringent as these provisions or a plan that complies with certain federal statutes. Authorizes the attorney general to bring an action to enforce the disclosure requirements. Makes certain information that relates to a license application submitted to the Indiana gaming commission confidential. Provides that a person who disposes of a customer's unencrypted, unredacted personal information without first shredding, incinerating, mutilating, or erasing the personal information commits a Class C infraction. Enhances the offense to a Class A infraction for a second or subsequent offense, or if the person has unlawfully disposed of the personal information of more than 100 customers. Includes as personal information certain information collected as part of a license or permit application. Provides that a person who unlawfully obtains the identifying information of a deceased person commits identity deception. Makes identity deception a Class C felony if a person unlawfully obtains the identities of more than 100 persons or the fair market value of the fraud or harm caused by the identity theft is at least \$50,000. Makes possession of a card skimming device with the intent to commit identity deception or fraud a Class D felony and a Class C felony if the device is possessed with the intent to commit terroristic deception. Permits a court to enter a restitution order requiring a person convicted of identity deception to reimburse the victim for additional expenses that arise or are discovered after sentencing or after the entry of a restitution order. Grants a court a five year period in which to order a person convicted of identity deception to pay additional restitution. Provides that a person who commits the offense of identity deception may be tried in any county in which any element of the offense occurs. Provides that jurisdiction for cases of identity deception lies in Indiana if the victim resides in Indiana. Imposes certain fiduciary obligations on members of the governing board of a county hospital, and specifies that if a hospital governing board has two physician members, only one physician member is required to be an active member of the medical staff of the hospital.

ENGROSSED HOUSE BILL No. 1101

A BILL FOR AN ACT to amend the Indiana Code concerning commercial law.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 4-33-5-1.5 IS ADDED TO THE INDIANA CODE
2 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2006]:

4 **Sec. 1.5. The following information submitted, collected, or**
5 **gathered as part of an application to the commission for a license**
6 **is confidential for purposes of IC 5-14-3-4:**

- 7 (1) Any information concerning a minor child of an applicant.
8 (2) The Social Security number of an applicant or the spouse
9 of an applicant.
10 (3) The home telephone number of an applicant or the spouse
11 of an applicant.
12 (4) An applicant's birth certificate.
13 (5) An applicant's driver's license number.
14 (6) The name or address of a previous spouse of the applicant.

4 SECTION 2. IC 4-33-5-2 IS AMENDED TO READ AS FOLLOWS
 5 [EFFECTIVE JULY 1, 2006]: Sec. 2. Notwithstanding any other law,
 6 upon written request from a person, the commission shall provide the
 7 following information to the person:

- 8 (1) **Except as provided in section 1.5 of this chapter**, the
 9 information provided under section 1 of this chapter concerning
 10 a licensee or an applicant.
- 11 (2) The amount of the wagering tax and admission tax paid daily
 12 to the state by a licensed owner or an operating agent.
- 13 (3) A copy of a letter providing the reasons for the denial of an
 14 owner's license or an operating agent's contract.
- 15 (4) A copy of a letter providing the reasons for the commission's
 16 refusal to allow an applicant to withdraw the applicant's
 17 application.

18 SECTION 3. IC 16-22-2-10 IS AMENDED TO READ AS

Chapter 2.5. Standards for Members of a Governing Board

Sec. 1. (a) A member of a governing board shall, based on facts then known to the member, discharge the member's duties as follows:

- (1) In good faith.**
- (2) With the care an ordinarily prudent person in a like position would exercise under similar circumstances.**
- (3) In a manner the member reasonably believes to be in the best interests of the hospital.**

(b) In discharging the member's duties, a member may rely on information, opinions, reports, or statements, including financial statements and other financial data, if prepared or presented by one (1) of the following:

- (1) A person whom the member reasonably believes to be reliable and competent in the matters presented.**
- (2) Legal counsel, public accountants, or other persons as to matters the member reasonably believes are within the person's professional or expert competence.**

(c) A member is not acting in good faith if the member has knowledge concerning a matter in question that makes reliance otherwise permitted by subsection (b) unwarranted.

Sec. 2. All proprietary and competitive information concerning the county hospital is confidential. A member of a governing board may not disclose confidential information concerning the county hospital to any person not authorized to receive this information.

Sec. 3. (a) A member of a governing board who violates this chapter may be removed from the governing board by action of the board.

- (b) The county executive may not:**
 - (1) reappoint to a governing board; or**
 - (2) appoint to a governing board;**

an individual who violated this chapter while serving or after serving as a member of a governing board.

Sec. 4. (a) A licensed physician is eligible for appointment to a county hospital governing board only if the physician is an active member of the medical staff of the hospital or holds a position that is equivalent to being an active member of the medical staff of the hospital.

(b) A physician who is terminated from the medical staff of the hospital is removed from the governing board by operation of law.

(c) A physician whose clinical privileges or staff membership

(d) If a hospital governing board has two (2) physician members under IC 16-22-2-7 or IC 16-22-2-8, only one (1) physician member must be an active member of the medical staff of the hospital or hold a position that is equivalent to being an active member of the medical staff of the hospital.

SECTION 5. IC 24-4-14 IS ADDED TO THE INDIANA CODE AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2006]:

Chapter 14. Persons Holding a Customer's Personal Information

Sec. 1. This chapter does not apply to the following:

- (1) The executive, judicial, or legislative department of state government or any political subdivision.
- (2) A unit (as defined in IC 36-1-2-23).
- (3) The office of county auditor.
- (4) The office of county treasurer.
- (5) The office of county recorder.
- (6) The office of county surveyor.
- (7) A county sheriff's department.
- (8) The office of county coroner.
- (9) The office of county assessor.
- (10) A person who engages in the business of waste collection, except to the extent the person holds a customer's personal information directly in connection with the business of waste collection.
- (11) A person who maintains and complies with a disposal program under:
 - (A) the federal USA Patriot Act (P.L.107-56);
 - (B) Executive Order 13224;
 - (C) the federal Driver's Privacy Protection Act (18 U.S.C. 2721 et seq.);
 - (D) the federal Fair Credit Reporting Act (15 U.S.C. 1681 et seq.);
 - (E) the federal Financial Modernization Act of 1999 (15 U.S.C. 6801 et seq.); or
 - (F) the federal Health Insurance Portability and Accountability Act (HIPAA) (P.L.104-191);
 if applicable.

Sec. 2. As used in this chapter, "customer" means a person who:
(1) has:

14 Sec. 4. For purposes of this chapter, personal information is
 15 "encrypted" if the personal information:

- 16 (1) has been transformed through the use of an algorithmic
 17 process into a form in which there is a low probability of
 18 assigning meaning without use of a confidential process or
 19 key; or
- 20 (2) is secured by another method that renders the personal
 21 information unreadable or unusable.

22 Sec. 5. As used in this chapter, "person" means an individual, a
 23 partnership, a corporation, a limited liability company, or another
 24 organization.

25 Sec. 6. As used in this chapter, "personal information" has the
 26 meaning set forth in IC 24-4.9-2-10. The term includes information
 27 stored in a digital format.

28 Sec. 7. (a) For purposes of this chapter, personal information is
 29 "redacted" if the personal information has been altered or
 30 truncated so that not more than the last four (4) digits of:

- 31 (1) a driver's license number;
- 32 (2) a state identification number; or
- 33 (3) an account number;

34 is accessible as part of personal information.

35 (b) For purposes of this chapter, personal information is
 36 "redacted" if the personal information has been altered or
 37 truncated so that not more than five (5) digits of a Social Security
 38 number are accessible as part of personal information.

18 **Sec. 2. (a) "Breach of the security of a system" means**
 19 **unauthorized acquisition of computerized data that compromises**
 20 **the security, confidentiality, or integrity of personal information**
 21 **maintained by a person. The term includes the unauthorized**
 22 **acquisition of computerized data that have been transferred to**
 23 **another medium, including paper, microfilm, or a similar medium,**
 24 **even if the transferred data are no longer in a computerized**
 25 **format.**

26 **(b) The term does not include the following:**

- 27 (1) **Good faith acquisition of personal information by an**
 28 **employee or agent of the person for lawful purposes of the**
 29 **person, if the personal information is not used or subject to**
 30 **further unauthorized disclosure.**
- 31 (2) **Unauthorized acquisition of a portable electronic device on**

 33 **protected by a password that has not been disclosed.**

34 **Sec. 3. "Data base owner" means a person that owns or licenses**

36 **Sec. 4. "Doing business in Indiana" means owning or using the**

 38 **purposes.**

39 **Sec. 5. Data are encrypted for purposes of this article if the**

14 **Sec. 8. "Mail" has the meaning set forth in IC 23-1-20-15.**

15 **Sec. 9. "Person" means an individual, a corporation, a business**
 16 **trust, an estate, a trust, a partnership, an association, a nonprofit**
 17 **corporation or organization, a cooperative, or any other legal**
 18 **entity.**

19 **Sec. 10. "Personal information" means:**

- 20 **(1) a Social Security number that is not encrypted or**
 21 **redacted; or**
 22 **(2) an individual's first and last names, or first initial and last**
 23 **name, and one (1) or more of the following data elements that**
 24 **are not encrypted or redacted:**
 25 **(A) A driver's license number.**
 26 **(B) A state identification card number.**

3 Chapter 3. Disclosure and Notification Requirements

4 Sec. 1. (a) Except as provided in section 4(c), 4(d), and 4(e) of
5 this chapter, after discovering or being notified of a breach of the
6 security of a system, the data base owner shall disclose the breach
7 to an Indiana resident whose:

- 8 (1) unencrypted personal information was or may have been
- 9 acquired by an unauthorized person; or
- 10 (2) encrypted personal information was or may have been
- 11 acquired by an unauthorized person with access to the
- 12 encryption key;

13 if the data base owner knows, should know, or should have known
14 that the unauthorized acquisition constituting the breach has
15 resulted in or could result in identity deception (as defined in
16 IC 35-43-5-3.5), identity theft, or fraud affecting the Indiana
17 resident.

18 (b) A data base owner required to make a disclosure under
19 subsection (a) to more than one thousand (1,000) consumers shall
20 also disclose to each consumer reporting agency (as defined in 15
21 U.S.C. 1681a(p)) information necessary to assist the consumer
22 reporting agency in preventing fraud, including personal
23 information of an Indiana resident affected by the breach of the
24 security of a system.

25 Sec. 2. A person that maintains computerized data but that is
26 not a data base owner shall notify the data base owner if the person
27 discovers that personal information was or may have been
28 acquired by an unauthorized person.

29 Sec. 3. (a) A person required to make a disclosure or notification
30 under this chapter shall make the disclosure or notification without
31 unreasonable delay. For purposes of this section, a delay is
32 reasonable if the delay is:

- 33 (1) necessary to restore the integrity of the computer system;
- 34 (2) necessary to discover the scope of the breach; or
- 35 (3) in response to a request from the attorney general or a law
36 enforcement agency to delay disclosure because disclosure
37 will:
- 38 (A) impede a criminal or civil investigation; or
- 39 (B) jeopardize national security.

40 (b) A person required to make a disclosure or notification under
41 this chapter shall make the disclosure or notification as soon as
42 possible after:

6 Sec. 4. (a) Except as provided in subsection (b), a data base
 7 owner required to make a disclosure under this chapter shall make
 8 the disclosure using one (1) of the following methods:

- 9 (1) Mail.
- 10 (2) Telephone.
- 11 (3) Facsimile (fax).
- 12 (4) Electronic mail, if the data base owner has the electronic
- 13 mail address of the affected Indiana resident.

14 (b) If a data base owner required to make a disclosure under
 15 this chapter is required to make the disclosure to more than five
 16 hundred thousand (500,000) Indiana residents, or if the data base
 17 owner required to make a disclosure under this chapter determines
 18 that the cost of the disclosure will be more than two hundred fifty
 19 thousand dollars (\$250,000), the data base owner required to make
 20 a disclosure under this chapter may elect to make the disclosure by
 21 using both of the following methods:

- 22 (1) Conspicuous posting of the notice on the web site of the
- 23 data base owner, if the data base owner maintains a web site.
- 24 (2) Notice to major news reporting media in the geographic
- 25 area where Indiana residents affected by the breach of the
- 26 security of a system reside.

27 (c) A data base owner that maintains its own disclosure
 28 procedures as part of an information privacy policy or a security
 29 policy is not required to make a separate disclosure under this
 30 chapter if the data base owner's information privacy policy or
 31 security policy is at least as stringent as the disclosure
 32 requirements described in:

- 33 (1) sections 1 through 4(b) of this chapter;
- 34 (2) subsection (d); or
- 35 (3) subsection (e).

36 (d) A data base owner that maintains its own disclosure
 37 procedures as part of an information privacy, security policy, or
 38 compliance plan under:

- 39 (1) the federal USA Patriot Act (P.L. 107-56);
- 40 (2) Executive Order 13224;

 18 Member Notice, as applicable, is not required to make a disclosure
 19 under this chapter.

20 (f) A person required to make a disclosure under this chapter
 21 may elect to make all or part of the disclosure in accordance with
 22 subsection (a) even if the person could make the disclosure in
 23 accordance with subsection (b).

24 **Chapter 4. Enforcement**

25 **Sec. 1. (a)** A person that is required to make a disclosure or
 26 notification in accordance with IC 24-4.9-3 and that fails to comply
 27 with any provision of this article commits a deceptive act that is
 28 actionable only by the attorney general under this chapter.

29 (b) A failure to make a required disclosure or notification in
 30 connection with a related series of breaches of the security of a
 31 system constitutes one (1) deceptive act.

32 **Sec. 2.** The attorney general may bring an action under this
 33 chapter to obtain any or all of the following:

- 34 (1) An injunction to enjoin future violations of IC 24-4.9-3.
- 35 (2) A civil penalty of not more than one hundred fifty
- 36 thousand dollars (\$150,000) per deceptive act.
- 37 (3) The attorney general's reasonable costs in:
 - 38 (A) the investigation of the deceptive act; and
 - 39 (B) maintaining the action.

SECTION 7. IC 35-32-2-6 IS ADDED TO THE INDIANA CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2006]: **Sec. 6. (a) Subject to subsection (b), a person who commits the offense of identity deception may be tried in a county in which:**

(1) the victim resides; or

(2) the person:

- (9) The personal financial records of the spouse or minor child of an applicant."**
