MR. SPEAKER:

I move that House Bill 1338 be amended to read as follows:

- 1 Page 1, delete lines 1 through 17.
- 2 Page 2, delete lines 1 through 18, begin a new paragraph and insert:
- 3 "SECTION 1. IC 20-28-5-3, AS ADDED BY P.L.246-2005,
- 4 SECTION 157, IS AMENDED TO READ AS FOLLOWS
- 5 [EFFECTIVE JULY 1, 2006]: Sec. 3. (a) The department shall
- 6 designate:
- 7 (1) the grade point average required for each type of license; and
- 8 (2) the types of licenses to which the teachers' minimum salary
- 9 laws apply, including nonrenewable one (1) year limited licenses.
- 10 (b) The department shall determine details of licensing not provided
- 11 in this chapter, including requirements regarding the following:
- 12 (1) The conversion of one (1) type of license into another.
- 13 (2) The accreditation of teacher education schools and
- 14 departments.
- 15 (3) The exchange and renewal of licenses.
- 16 (4) The endorsement of another state's license.
- 17 (5) The acceptance of credentials from teacher education
- 18 institutions of another state.
- 19 (6) The academic and professional preparation for each type of
- 20 license.
- 21 (7) The granting of permission to teach a high school subject area
- 22 related to the subject area for which the teacher holds a license.
- 23 (8) The issuance of licenses on credentials.
- 24 (9) The type of license required for each school position.
- 25 (10) The size requirements for an elementary school requiring a

1 licensed principal.
 2 (11) Any other related matters.
 3 The department shall establish at least one (1) system for renewing a
 4 teaching license that does not require a graduate degree.

5 **(c) Beginning July 1, 2006, the board, before issuing an initial**
 6 **teaching license at any grade level to an undergraduate individual**
 7 **seeking an initial teaching license, shall require the applicant for a**
 8 **license to show evidence that the applicant meets one (1) of the**
 9 **following:**

10 **(1) Has successfully completed a course approved by the**
 11 **board in:**

12 **(A) cardiopulmonary resuscitation that includes a test**
 13 **demonstration on a mannequin;**

14 **(B) removing a foreign body causing an obstruction in an**
 15 **airway; and**

16 **(C) the Heimlich maneuver.**

17 **(2) Holds a valid certification in the procedures described in**
 18 **subdivision (1) issued by:**

19 **(A) the American Red Cross;**

20 **(B) the American Heart Association; or**

21 **(C) a comparable organization or institution approved by**
 22 **the board.**

23 **(3) Has physical limitations that make it impracticable for the**
 24 **applicant to complete a course or certification described in**
 25 **subdivision (1) or subdivision (2).**

26 ~~(c)~~ **(d) The department shall periodically publish bulletins regarding:**

27 **(1) the details described in subsection (b);**

28 **(2) information on the types of licenses issued;**

29 **(3) the rules governing the issuance of each type of license; and**

30 **(4) other similar matters."**

31 Page 4, delete lines 2 through 42, begin a new paragraph and insert:

32 "SECTION 4. IC 34-30-14-2.5 IS ADDED TO THE INDIANA
 33 CODE AS A NEW SECTION TO READ AS FOLLOWS
 34 [EFFECTIVE JULY 1, 2006]: **Sec. 2.5. A teacher who:**

35 **(1) meets the requirement of IC 20-28-5-3(c); and**

36 **(2) performs:**

37 **(A) cardiopulmonary resuscitation; or**

38 **(B) the Heimlich maneuver;**

39 **on or removes a foreign body that is obstructing an airway of**
 40 **another person in the course of employment as a teacher;**

41 **is not liable in a civil action for damages resulting from an act or**
 42 **omission occurring during the performance of a function under this**
 43 **section unless the act or omission constitutes gross negligence or**
 44 **willful and wanton misconduct.**

45 SECTION 5. [EFFECTIVE UPON PASSAGE] **(a) Although**
 46 **IC 20-28-5-3(c), as amended by this act, applies beginning July 1,**

1 **2006, a college or university located in Indiana may recommend to**
2 **a person who has been accepted in a teacher training program**
3 **before July 1, 2006, that the person should meet the requirements**
4 **of IC 20-28-5-3(c), as amended by this act.**

5 **(b) This SECTION expires June 30, 2008.**
6 **SECTION 6. An emergency is declared for this act."**
7 Page 5, delete lines 1 through 2.
8 Re-number all SECTIONS consecutively.
