DIGEST OF INTRODUCED BILL

Citations Affected: IC 6-3.1-10-4.

Synopsis: Enterprise zone investment cost credit. Provides that trusts, estates, corporations, and pass through entities that make qualified investments in enterprise zone businesses may claim the enterprise zone investment cost credit. (Current law allows only individuals to claim the credit, except in Vigo County where pass through entities are also eligible.)

Effective: January 1, 2007.

A BILL FOR AN ACT to amend the Indiana Code concerning taxation.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 6-3.1-10-4 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE JANUARY 1, 2007]: Sec. 4. ~~(a)~~ As used in
3 this chapter, "taxpayer" means any: ~~individual that has any state tax~~
4 ~~liability.~~

- 5 (1) person;
- 6 (2) corporation; or
- 7 (3) pass through entity;
- 8 **that has any state tax liability.**

9 (b) Notwithstanding subsection (a); for a credit for a qualified
10 investment in a business located in an enterprise zone in a county
11 having a population of more than one hundred five thousand (105,000)
12 but less than one hundred ten thousand (110,000); "taxpayer" includes
13 a pass through entity.

14 SECTION 2. [EFFECTIVE JANUARY 1, 2007] IC 6-3.1-10-4, as
15 amended by this act, applies to taxable years beginning after
16 December 31, 2006.
