DIGEST OF INTRODUCED BILL

Citations Affected: IC 9-18-17-4.

Synopsis: Parking with former prisoner of war plates. Provides that a person issued a former prisoner of war license plate may not be charged: (1) a fee for parking the vehicle displaying the plate in a metered space; or (2) a penalty for parking the vehicle displaying the plate in a metered space for longer than the time permitted.

Effective: July 1, 2006.

HOUSE BILL No. 1305



A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 9-18-17-4 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2006]: **Sec. 4. (a) A person who has been issued a license plate**
4 **under this chapter designating the person's motor vehicle as being**
5 **owned or leased by a former prisoner of war may not be:**
6 (1) **charged a fee for parking the motor vehicle displaying the**
7 **license plate in a metered space; or**
8 (2) **assessed a penalty for parking the motor vehicle displaying**
9 **the license plate in a metered space for longer than the time**
10 **permitted by the meter.**
11 (b) **This section does not authorize parking a motor vehicle in a**
12 **place where parking is not allowed at any time if the prohibition is:**
13 (1) **posted and authorized by a city or town ordinance; or**
14 (2) **by order of the Indiana department of transportation.**
15 (c) **A person other than the owner or lessee of a motor vehicle**
16 **displaying a former prisoner of war license plate issued under this**
17 **chapter is not entitled to the parking privileges established by this**
