

SENATE MOTION

MADAM PRESIDENT:

I move that Senate Bill 112 be amended to read as follows:

- 1 Page 19, between lines 19 and 20, begin a new paragraph and
2 insert:
3 "SECTION 16. IC 20-20-1-2, AS ADDED BY P.L.1-2005, SECTION
4 4, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,
5 2006]: Sec. 2. (a) As used in this chapter, "educational service center"
6 means an extended agency of school corporations that:
7 (1) operates under rules established by the state board;
8 (2) is the administrative and operational unit that serves a
9 definitive geographical boundary; and
10 (3) allows school corporations to voluntarily cooperate and share
11 programs and services that the school corporations cannot
12 individually provide but collectively may implement.
13 (b) Programs and services collectively implemented through an
14 educational service center may include, but are not limited to, the
15 following:
16 (1) Curriculum development.
17 (2) Pupil personnel and special education services.
18 (3) In-service education.
19 (4) State-federal liaison services.
20 (5) Instructional materials and multimedia services.
21 (6) Vocational and career education.
22 (7) Purchasing and financial management, **including the**
23 **following types of purchases and services:**
24 **(A) School buses and other vehicles.**
25 **(B) Fuel, maintenance, or other services for vehicles.**
26 **(C) Energy needs. At least each school corporation shall,**
27 **and more than one (1) school corporation acting jointly**
28 **may, be considered a single purchaser of energy.**
29 **(D) Food services.**
30 **(E) Facilities.**
31 **(F) Transportation.**
32 **(G) Textbooks, technology, and other school materials**

1 **and supplies.**
2 **(H) Insurance.**
3 **(I) Any other purchases a school corporation may**
4 **require.**
5 (8) Needs assessment.
6 (9) Computer use.
7 (10) Research and development.
8 SECTION 17. IC 20-20-33 IS ADDED TO THE INDIANA
9 CODE AS A NEW CHAPTER TO READ AS FOLLOWS
10 [EFFECTIVE JULY 1, 2006]:
11 **Chapter 33. Early Education Trust Fund**
12 **Sec. 1. As used in this chapter, "fund" refers to the early**
13 **education trust fund established by section 2 of this chapter.**
14 **Sec. 2. (a) The early education trust fund is established for the**
15 **purpose of receiving, holding, and disbursing funds and grants for**
16 **early education initiatives and programs under this chapter. The**
17 **fund shall be administered by the department.**
18 **(b) The fund consists of money appropriated by the general**
19 **assembly, federal grants, and private grants and gifts.**
20 **(c) The treasurer of state shall invest the money in the fund not**
21 **currently needed to meet the obligations of the fund in the same**
22 **manner as other public money may be invested. Interest that**
23 **accrues from these investments shall be deposited in the fund.**
24 **(d) Money in the fund at the end of a state fiscal year does not**
25 **revert to the state general fund.**
26 **(e) There is appropriated continuously to the department from**
27 **the fund the amount necessary to carry out the purposes of this**
28 **chapter.**
29 **Sec. 3. (a) When funds are available, the department shall call**
30 **for proposals from school corporations, schools, units of local**
31 **government, and private entities to provide programs for children**
32 **from birth through seven (7) years of age, including the following**
33 **types of programs:**
34 **(1) Full-day kindergarten.**
35 **(2) Early reading programs, such as the Imagination**
36 **Library.**
37 **(3) Head Start and preschool programs, including the**
38 **expansion of existing programs.**
39 **(4) Parental education programs, such as Parents as**
40 **Teachers.**
41 **(5) Any other innovative program or service that provides**
42 **early childhood education.**
43 **(b) The department may establish matching fund requirements**
44 **to receive grants from the fund. An entity seeking a grant that**
45 **requires a match may use federal funds, state funds, local funds**
46 **including property tax revenues, private funds, and in-kind**
47 **matches for the match.**
48 **Sec. 4. (a) The department shall:**
49 **(1) evaluate and rank proposals received under section 3 of**
50 **this chapter; and**
51 **(2) present the results of the rankings to the state board.**
52 **(b) The state board shall decide which proposals will receive**

1 grants from the fund.

2 **Sec. 5. The state board shall adopt rules under IC 4-22-2 to**
 3 **carry out this chapter. Rules adopted under this section must**
 4 **include criteria for consideration in evaluating programs and**
 5 **establishing matching requirements.**

6 SECTION 18. IC 20-26-5-1, AS ADDED BY P.L.1-2005,
 7 SECTION 10, IS AMENDED TO READ AS FOLLOWS
 8 [EFFECTIVE JULY 1, 2006]: Sec. 1. (a) A school corporation shall:

9 (1) conduct an educational program for all children who reside
 10 within the school corporation in kindergarten (**subject to**
 11 **subsection (e)**) and in grades 1 through 12; and

12 (2) provide each preschool child with a disability with an
 13 appropriate special education as required under IC 20-35-4-9
 14 only if the general assembly appropriates state funds for
 15 preschool special education.

16 (b) A school corporation may:

17 (1) conduct an educational program for adults and children at
 18 least fourteen (14) years of age who do not attend a program
 19 described in subsection (a);

20 (2) provide instruction in vocational, industrial, or manual
 21 training;

22 (3) provide libraries for the schools of the school corporation;

23 (4) provide public libraries open and free for the use and benefit
 24 of the residents and taxpayers of the school corporation where
 25 permitted by law;

26 (5) provide vacation school and recreational programs;

27 (6) conduct other educational or other activities as are permitted
 28 or required to be performed by law by any school corporation;
 29 and

30 (7) provide a school age child care program that operates during
 31 periods when school is in session for students who are enrolled
 32 in a half-day kindergarten program.

33 (c) A school corporation shall develop a written policy that
 34 provides for:

35 (1) the implementation of a school age child care program for
 36 children who attend kindergarten through grade 6 that, at a
 37 minimum, operates after the school day and may include periods
 38 before school is in session or periods when school is not
 39 otherwise in session (commonly referred to as a latch key
 40 program) and is offered by the school corporation; or

41 (2) the availability of the school corporation's buildings or parts
 42 of the school corporation's buildings to conduct the type of
 43 program described in subdivision (1) by a nonprofit organization
 44 or a for-profit organization.

45 (d) The written policy required under subsection (c) must address
 46 compliance with certain standards of reasonable care for children
 47 served by a child care program offered under subsection (c), including:

48 (1) requiring the offering entity to acquire a particular amount of
 49 liability insurance; and

50 (2) establishing maximum adult to child ratios governing the

1 overall supervision of the children served.
 2 If a school corporation implements a child care program as described
 3 in subsection (c)(1) or enters into a contract with an entity described in
 4 subsection (c)(2) to provide a child care program, the school
 5 corporation may not assess a fee for the use of the building, and the
 6 contract between the school corporation and the entity providing the
 7 program must be in writing. However, the school corporation may
 8 assess a fee to reimburse the school corporation for providing security,
 9 maintenance, utilities, school personnel, or other costs directly
 10 attributable to the use of the building for the program. In addition, if a
 11 school corporation offers a child care program as described in
 12 subsection (c)(1), the school corporation may assess a fee to cover costs
 13 attributable to implementing the program.

14 **(e) Beginning with the 2007-2008 school year, a school**
 15 **corporation shall offer a full-day kindergarten program in any**
 16 **school within the school corporation that has kindergarten classes**
 17 **and that is eligible to receive federal funding under Title I.**
 18 **Beginning with the 2009-2010 school year, a school corporation**
 19 **shall offer a full-day kindergarten program in each school within**
 20 **the school corporation that has kindergarten classes. However, a**
 21 **parent may elect:**

- 22 **(1) not to send a child to kindergarten; or**
 23 **(2) to send a child to kindergarten for only a half day.**

24 ~~(f)~~ **(f)** The powers under this section are purposes as well as
 25 powers."

26 Page 21, between lines 16 and 17, begin a new paragraph and
 27 insert:

28 "SECTION 20. [EFFECTIVE JULY 1, 2006] **(a) There is**
 29 **appropriated to the department of education one million five**
 30 **hundred thousand dollars (\$1,500,000) from the state general fund**
 31 **to fund the disbursement of the early education trust fund**
 32 **(established by IC 20-20-33-2, as added by this act) to the**
 33 **Imagination Library beginning July 1, 2006, and ending June 30,**
 34 **2007.**

35 **(b) Before January 1, 2007, the department of education shall**
 36 **enter into an agreement with the Imagination Library to establish**
 37 **a free book program for children from birth through five (5) years**
 38 **of age in Indiana.**

39 **(c) This SECTION expires July 1, 2007.**

40 SECTION 21. [EFFECTIVE JULY 1, 2006] **(a) The department**
 41 **of education shall enter into an agreement with an entity qualified**
 42 **to conduct a study and prepare a report on the amount of money**
 43 **attributable to each factor within the complexity index determined**
 44 **under IC 21-3-1.7-6.7 and to develop a fixed cost index for each**
 45 **school corporation in Indiana.**

46 **(b) Not later than January 1, 2007, the entity with which the**
 47 **department of education enters into an agreement under subsection**
 48 **(a) shall submit the report required under subsection (a) to the**
 49 **following:**

- 50 **(1) The state board of education.**

- 1 **(2) The education roundtable.**
- 2 **(3) The governor.**
- 3 **(4) The general assembly. A report under this subdivision**
- 4 **must be in an electronic format under IC 5-14-6.**
- 5 **(5) The public.**
- 6 **(c) This SECTION expires June 30, 2007."**
- 7 Renumber all SECTIONS consecutively.
