

# SENATE MOTION

**MADAM PRESIDENT:**

**I move** that Engrossed House Bill 1011 be amended to read as follows:

- 1           Page 1, between the enacting clause and line 1, begin a new  
2 paragraph and insert:  
3           "SECTION 1. IC 3-5-2-40.5, AS ADDED BY P.L.109-2005,  
4 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
5 JULY 1, 2006]: Sec. 40.5. **(a) Subject to subsections (b) and (c), an**  
6 **individual provides "proof of identification" refers to a document that**  
7 **satisfies all by presenting one (1) of the following documents issued**  
8 **to the individual if (†) the document shows the name of the individual**  
9 **to whom the document was issued; and the name conforms to the name**  
10 **in the individual's voter registration record:**  
11           (2) The document shows a photograph of the individual to whom  
12 the document was issued.  
13           (3) The document includes an expiration date; and the document:  
14           (A) is not expired; or  
15           (B) expired after the date of the most recent general election.  
16           (4) The document was issued by the United States or the state of  
17 Indiana.  
18           (1) Identification issued by the state of Indiana or a county  
19 voter registration office.  
20           (2) Identification issued by the United States.  
21           (3) Identification issued by:  
22           (A) a state educational institution (as defined in  
23 IC 20-12-0.5-1); or  
24           (B) a private institution of higher education located in  
25 Indiana, including a university, college, vocational school,  
26 or technical school, that is accredited by a recognized  
27 regional accrediting agency.  
28           (4) A copy of a current utility bill, bank statement, paycheck,  
29 government check, or another government document that  
30 shows the name and address of the voter.

- 1           **(5) A driver's license or state identification card issued by a**
- 2           **state other than Indiana.**
- 3           **(b) In addition to the method of providing proof of identification**
- 4           **set forth in subsection (a), a voter provides proof of identification**
- 5           **if two (2) precinct election officers who are members of different**
- 6           **major political parties execute under the penalties of perjury an**
- 7           **affidavit:**
- 8           **(1) that is on a form prescribed by the commission;**
- 9           **(2) that is signed by:**
- 10           **(A) the precinct election officers; and**
- 11           **(B) the voter; and**
- 12           **(3) in which the precinct election officers swear or affirm that:**
- 13           **(A) the precinct election officers have personal knowledge**
- 14           **of the voter; and**
- 15           **(B) the voter is the individual whose name appears on the**
- 16           **poll list.**
- 17           **(c) In addition to the method of providing proof of identification**
- 18           **set forth in subsection (a), a voter provides proof of identification**
- 19           **by executing under the penalties of perjury an affidavit:**
- 20           **(1) that is on a form prescribed by the commission; and**
- 21           **(2) in which the voter swears or affirms that the voter is the**
- 22           **individual whose name appears on the poll list."**
- 23           Renumber all SECTIONS consecutively.
