MR. SPEAKER:

I move that Engrossed Senate Bill 327 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 20-34-3-16.5 IS ADDED TO THE INDIANA
- 4 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
- 5 [EFFECTIVE JULY 1, 2007]: **Sec. 16.5. (a) As used in this section,**
- 6 **"school" refers to the following:**
- 7 (1) **A public school.**
- 8 (2) **An accredited nonpublic school.**
- 9 (3) **A charter school.**
- 10 (b) **The term does not include a school that provides solely home**
- 11 **based instruction.**
- 12 (c) **Beginning in the 2008-2009 school year, every male child,**
- 13 **before the child enters grade 12 at a school, shall be tested for the**
- 14 **human papillomavirus (HPV) infection.**
- 15 (d) **Each school shall notify each parent or legal guardian of a**
- 16 **student who enrolls in grade 12 in the school of the requirement**
- 17 **that the student must be tested and that the test is required for the**
- 18 **student's continued enrollment, attendance, or residence at the**
- 19 **school.**
- 20 (e) **Each school shall require the parent or legal guardian of a**
- 21 **student who has enrolled in the school to furnish, not later than the**
- 22 **first day of school, a written statement of the student's test,**
- 23 **accompanied by the physician's certificate or other documentation,**
- 24 **unless a written statement of this nature is on file with the school.**

1 **(f) The statement must show, except for a student to whom**
2 **section 2 or 3 of this chapter applies, that the student has been**
3 **tested as required in this section. The statement must include the**
4 **student's date of birth and the date of the test.**

5 **(g) A student may not be permitted to attend school beyond the**
6 **first day of school without furnishing the written statement unless:**

7 **(1) the school gives the parent of the student a waiver; or**

8 **(2) the local health department or a physician determines that**
9 **the student's test has been delayed due to extreme**
10 **circumstances and that the required test will not be completed**
11 **before the first day of school.**

12 **The waiver referred to in subdivision (1) may not be granted for a**
13 **period that exceeds twenty (20) days. If subdivision (2) applies, the**
14 **parent of the student shall furnish the written statement and a**
15 **schedule, approved by a physician or the local health department,**
16 **for the completion of the test."**

17 Renumber all SECTIONS consecutively.
