I move that Engrossed Senate Bill 557 be amended to read as follows:

- 1 Page 1, line 4, delete "ultimate" and insert "**the following:**
- 2 **(1) Ultimate fighting.**
- 3 **(2) Ultimate Fighting Championships.**
- 4 **(3) Mixed martial arts.**
- 5 **(4) Martial arts, including the following:**
- 6 **(A) Jujutsu.**
- 7 **(B) Karate.**
- 8 **(C) Kickboxing.**
- 9 **(D) Kung fu.**
- 10 **(E) Tae kwon do.**
- 11 **(5) Professional wrestling."**
- 12 Page 1, delete lines 5 through 6.
- 13 Page 2, line 8, delete "or Ultimate Fighting Championships".
- 14 Page 2, between lines 10 and 11, begin a new line block indented
- 15 and insert:
- 16 **"(3) Ultimate Fighting Championships, as defined by the state**
- 17 **boxing commission in rules adopted under IC 25-9-1-4.5;**
- 18 **(4) mixed martial arts, as defined by the state boxing**
- 19 **commission in rules adopted under IC 25-9-1-4.5;**
- 20 **(5) martial arts, as defined by the state boxing commission in**
- 21 **rules adopted under IC 25-9-1-4.5;"**.
- 22 Page 2, line 11, delete "(3)" and insert "**(6)**".
- 23 Page 2, line 13, delete "(4)" and insert "**(7)**".
- 24 Page 2, line 16, delete "promotes or".

- 1 Page 2, line 18, delete "Class A" and insert "**Class C**".
- 2 Page 2, between lines 18 and 19, begin a new paragraph and insert:
- 3 "**Sec. 3. A person who knowingly or intentionally promotes or**
- 4 **organizes combative fighting commits unlawful promotion or**
- 5 **organization of combative fighting, a Class A misdemeanor.**
- 6 **However, the offense is a Class D felony if, within the five (5) years**
- 7 **preceding the commission of the offense, the person had a prior**
- 8 **unrelated conviction under this section."**
- 9 Page 2, line 19, delete "," and insert "**and IC 35-45-18-3, both**".
- 10 Page 2, line 20, delete "applies" and insert "**apply**".
