HOUSE BILL No. 1288

DIGEST OF HB 1288 (Updated February 14, 2007 8:46 pm - DI 114)

Citations Affected: IC 20-20; IC 20-33; noncode.

Synopsis: School attendance officers. Requires school corporations to include information on their truancy rates in their annual performance reports. Provides that beginning with the 2008-2009 school year: (1) the department of education shall rank all school corporations according to their truancy rates; and (2) each school that has an enrollment of at least 500 students within a school corporation ranked among the 25% of all school corporations having the highest truancy rates shall appoint an attendance officer.

Effective: July 1, 2007.

HOUSE BILL No. 1288

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 20-20-8-8, AS AMENDED BY P.L.185-2006,
2 SECTION 7, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2007]: Sec. 8. The report must include the following

6 (2) Graduation rate (as defined in IC 20-26-13-6).

8 (4) The following test scores, including the number and

10 (A) ISTEP program test scores.
11 (B) Scores for assessments under IC 20-32-5-21, if
12 appropriate.
13 (C) For a freeway school, scores on a locally adopted
14 assessment program, if appropriate.
15 (5) Average class size.
16 (6) The number and percentage of students in the following
17 groups or programs:

- 25 SECTION 2. IC 20-33-2-38.1 IS ADDED TO THE INDIANA
- 26 CODE AS A NEW SECTION TO READ AS FOLLOWS
- 27 [EFFECTIVE JULY 1, 2007]: **Sec. 38.1. Notwithstanding any other**
- 28 **law, beginning with the 2008-2009 school year, each school that has**
- 29 **an enrollment of at least five hundred (500) students within a**
- 30 **school corporation that is ranked among the twenty-five percent**
- 31 **(25%) of all school corporations having the highest truancy rates,**
- 32 **according to the ranking performed by the department of**
- 33 **education based on truancy rates reported by school corporations**
- 34 **under IC 20-20-8-8(26), shall appoint an attendance officer to**
- 35 **carry out the attendance officer duties described in this chapter.**
- 36 SECTION 3. [EFFECTIVE JULY 1, 2007] (a) **Beginning with the**
- 37 **2007-2008 school year, the department of education shall annually**
- 38 **compile statistics concerning student truancy rates. The statistics**
- 39 **must include the number and percentage of truant students in each**
- 40 **school corporation, as reported by the school corporations under**
- 41 **IC 20-20-8-8(26), as amended by this act.**
- 42 (b) **The department of education shall annually rank all of the**

1 school corporations based on the statistics compiled under
2 subsection (a), placing the school corporations in order according
3 to their truancy rates, from the highest truancy rate to the lowest
4 truancy rate.

5 (c) This SECTION expires July 1, 2010.
