DIGEST OF HB 1665 (Updated February 8, 2007 10:45 am - DI 103)

Citations Affected: IC 20-20.

Synopsis: High school diplomas for veterans. Provides that a veteran of the Korean Conflict or the Vietnam Conflict who left a public or nonpublic high school without graduating in order to perform military service is an "eligible veteran" entitled to receive a high school diploma.

Effective: July 1, 2007.

HOUSE BILL No. 1665

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 20-20-7-3, AS ADDED BY P.L.1-2005, SECTION
2 4, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,
3 2007]: Sec. 3. As used in this chapter, "eligible veteran" refers to an
4 individual who has the following qualifications:
- 5 (1) Served as a member of the armed forces of the United States
6 at any time during at least one (1) of the following periods:
 - 7 (A) Beginning April 6, 1917, and ending November 11, 1918
8 (World War I).
 - 9 (B) Beginning December 7, 1941, and ending December 31,
10 1946 (World War II).
 - 11 (C) **Beginning June 27, 1950, and ending January 31, 1955**
12 **(Korean Conflict).**
 - 13 (D) **Beginning August 5, 1964, and ending May 7, 1975**
14 **(Vietnam Conflict).**
 - 15 (2) Before the military service described in subdivision (1):
 - 16 (A) attended a public or nonpublic high school in Indiana; and
 - 17 (B) was a student in good standing at the high school

2 department of veterans' affairs.
3 (3) Did not graduate or receive a diploma because of leaving the
4 high school described in subdivision (2) for the military service
